## 1. Purpose of this document

- 1.1. This sustainability appraisal has been prepared in support of the emerging Anglesey Neighbourhood Development Plan (ANDP). This document looks to the sustainability objectives set out in the Sustainability Appraisal of the East Staffordshire development plan to produce sustainability objectives for the ANDP. This appraisal will go on to assess if the ANDP vision, objectives and policies comply with the sustainability objectives.
- 1.2. Anglesey is an urban parish located in Burton upon Trent, in East Staffordshire. The East Staffordshire Local Plan was adopted in October 2015. The Local Plan replaced the saved policies of the 2006 Local Plan and sets out the strategic framework for development in the Borough during the period 2012-2031. The Local Plan has been subject to examination by an independent inspector appointed by the Secretary of State.

### The need for SEA

- 1.3. The Anglesey Neighbourhood Plan was the subject of a screening opinion undertaken by East Staffordshire Borough Council (ESBC) in June 2015. The statutory consultees made the following conclusions:
- 1.4. Environment Agency - "With regards to Anglesey I note they recognise the impact of flood risk and the assessment that will need to be undertaken to ensure and sites that come forward are suitable. Anglesey is entirely in the flood plain, although defended so any proposed sites will need to consider the impact should those defences become breached. Taking the above into consideration, with regards to the screening opinion for both these Neighbourhood Plans, [Anglesey and Stapenhill] we consider the plans would not have significant environmental effects and, as a result, a SEA of either plan would not be required."
- 1.5. Natural England - "Natural England does not consider the NDP need be accompanied by a HRA as proposals are unlikely to result in significant effects on the [River Mease] SAC. We note that whilst the proposed policies of the ANDP are allocating 3 new sites for development, they are unlikely to have significant environmental effects that have not already been considered and dealt with through a sustainability appraisal of the emerging Local Plan which is now at an advanced stage. Neither does the Plan Area contain sensitive natural assets that may be affected by the Plan policies. Therefore, it is Natural England's understanding that it is likely this Plan does not require a Strategic Environmental Assessment (SEA)."

- 1.6. Historic England - "On the basis of the information supplied, including that set out in the draft plan, and in the context of the criteria set out in Schedule 1 of the Environmental Assessment Regulations [Annex II of 'SEA' Directive], Historic England is of the view that the preparation of a Strategic Environmental Assessment is likely to be required as land allocations are made and any development proposed could affect heritage assets. As regards the HRA Screening Report Historic England does not wish to comment in detail and would defer to Natural England and other statutory consultees, however, we have no adverse comments to make on the report's conclusions."
- 1.7. As a result of the above, ESBC concluded that the Anglesey Neighbourhood Plan would have significant environmental effects, specifically on heritage assets in the parish and, as a result, a Strategic Environmental Assessment of the Plan will be required. It has been determined that only the policies which are considered to need SEA are assessed in this way. Therefore this document provides a full SA with SEA specific details relating only to Policy A14 – Brewery Buildings, Clarence Street (known as the Goat Maltings).
- 1.8. The document will include the following sections:

*1 – Analysis of Sustainability Objectives of the Sustainability Appraisal of the adopted Local Plan.*

*2 – Formulation of sustainability objectives for the Anglesey neighbourhood plan that take a lead from those set out in the adopted Local Plan but are tailored to the local scale and characteristics of Anglesey Parish.*

*3 – An assessment of policy A14 according to Schedule 2 of the Environmental Assessment of Plans and Programmes Regulations 2004.*

*4 – Assessment of the emerging Anglesey neighbourhood plan vision, objectives and policies with the Anglesey sustainability objectives.*

*5 – Conclusion as to the overall assessment of the Anglesey neighbourhood plan with its sustainability objectives.*

## **2. Setting of Sustainability Objectives**

- 2.1. East Staffordshire Revised Sustainability Report (2014) specifies 12 sustainability objectives, covering key sustainability themes. For the purpose of this document East Staffordshire's sustainability objectives have been labelled ESO1 to ESO12 and Anglesey's sustainable objectives have been labelled SO1 to DO13.
  
- 2.2. East Staffordshire's sustainability objectives are outlined in the Revised Sustainability Appraisal Report (2014). The objectives are as follows:

### **ESO1 – Housing**

To provide a suitable mix of decent housing available and affordable to everyone

**ESO2 - Economy:** To achieve a prosperous and diverse economy, encourage high and stable levels of employment and sustain economic competitiveness.

**ESO3 - Transportation:** To reduce the need to travel, encourage more sustainable modes of transport and make best use of existing transport infrastructure.

**ESO4 - Climate change, energy and air quality:** To reduce the causes and impacts of climate change, improve air quality, promote energy efficiency and encourage the use of renewable energy.

**ESO5 - High quality design and sustainability:** To encourage sustainable design and practice and create a high quality built environment.

**ESO6 - Green infrastructure and open space:** To protect, enhance and provide new Green Infrastructure assets.

**ESO7 - Town centre:** To sustain the vitality and viability of Burton and Uttoxeter town centres.

**ESO8 - Rural communities:** To sustain vibrant rural communities.

**ESO9 - Flood risk:** To reduce and manage the risk of flooding which would be detrimental to the public wellbeing, the economy and the environment.

**ESO10 - Use of land:** To deliver more sustainable use of land in more sustainable locations.

**ESO11 - Natural resources:** To ensure the prudent use of natural resources and the sustainable management of existing resources.

**ESO12 - Quality of life:** To improve the quality of life, including the health, safety and well being of those living and working in the borough.

2.3. Clear themes are apparent in the sustainability objectives identified in the Revised Sustainability Appraisal Report (2014). These themes form the basis of the Anglesey sustainability objectives (SO). They have been expanded upon to create 12 sustainability objectives for the parish of Anglesey as it moves forward with its neighbourhood plan. The sustainability objectives are as follows:

**SO1 - Housing (ESO1)** - Meeting the housing needs of the Anglesey's population, providing a suitable mix of decent housing available and affordable to everyone.

**SO2 - Economy (ESO2)** - To achieve a prosperous and diverse local economy, and increase overall employment and economic growth.

**SO3 - Sustainable transport (ESO3)** - To reduce the need to travel, encourage sustainable modes of travel and make best use of existing transport infrastructure within the parish.

**SO4 - Climate change, energy and air quality (ESO4)** - To reduce the causes and impacts of climate change, improve air quality, promote energy efficiency, reduce emissions and encourage the use of renewable energy.

**SO5 - Good design (ESO5)** - To encourage high quality, sustainable design and create a high quality built environment as Anglesey changes over the plan period.

**SO6 - Community facilities (ESO12)** - To protect, enhance and provide community facilities in the parish including education, health, recreation, shops and open spaces.

**SO7 - Town centre (ESO7)** - To sustain the vitality and viability of Burton town centre.

**SO8 - Vibrant communities (ESO12)** - To sustain the parish as a vibrant community and promote high quality of life for all who live, work and visit the Anglesey.

**SO9 - Flood risk and water quality (ESO9)** - To prioritise and at all times consider the safety and wellbeing of new and existing parish residents by reducing and managing factors such as flood risk, crime and traffic.

**SO10 - Natural resources (ESO11)** - To ensure the prudent use of natural and limited resources and manage these resources in a sustainable manner, e.g. land and energy.

**SO11 - Landscape quality (ESO5, ESO6)** - To protect, maintain and enhance the character and appearance of the landscape and townscape quality of the parish by maintaining and strengthening local distinctiveness, visual amenity, landscape character and sense of place.

**SO12 - Heritage and historic environment (ES05)** - To protect and enhance landscape character, historic buildings, archaeological sites and cultural features of importance to the community.

### **3. Schedule 2 assessment of policy A14: Goat Maltings**

- 3.1. Statutory consultee Historic England stated that policy A14 should be supported by SEA due to heritage designations affecting the site. The former Goat Maltings building, office block, loading bay and Malthouse of the former Yeomans, Cherry and Cutin Brewery, is grade II listed. It also lies within a Conservation Area and is part of a cluster of former brewery buildings, many of which have been converted to residential use. The Goat Maltings building itself does have planning permission for conversion to residential units however, the scheme has not been implemented.
- 3.2. The Neighbourhood Plan explored different options with the community and concluded that the ideal scenario would be for the building to be converted and retain in use as it is highly valued as a local historical and community landmark. The neighbourhood plan encourages this through “Policy A14 – Brewery Buildings, Clarence Street (known as the Goat Maltings)” which seeks redevelopment for residential, commercial, leisure and community uses which demonstrably appreciate the heritage value of the building.
- 3.3. The neighbourhood plan resists the loss of the building, seeks a full historical record of it prior to development, provision of interpretation boards to ensure the identity of the building is retained, parking and amenity space is provided sensitively.
- 3.4. The following table sets out the requirements of schedule 2 relating to this policy:

Alternatives explored were derived from consultation with the Anglesey parish community. The options were; no policy on the site, policy which looks to demolish/significantly alter the building and finally to convert with minimum impact on the fabric of the building. The first two options were not considered by the community or steering group to be realistic

	<p>options as the listing of the building and its significance within the townscape of the parish made it too important not to try to encourage its protection through the neighbourhood plan and too heavily protected and valued to remove.</p>

A description of the measures envisaged concerning monitoring in accordance with regulation 17.	<p>The neighbourhood plan, and in particular policy A14 will be subject to monitoring over the 'plan period' to which it relates. Monitoring will happen changing to the listing of the building, development of the site, alterations to the ESBC local plan which make the neighbourhood plan ineffectual. It is envisaged that a review will be undertaken 5 to 6 years from adoption of the neighbourhood plan.</p>

#### 4. Sustainability appraisal:

##### **Testing the vision, objectives and draft policies against the ANDP sustainability objectives**

- 4.1. The ANDP sustainability objectives, as detailed in the previous section, are now used to assess the vision, objectives and draft policies. The following table demonstrates the coding used to grade the vision, objective or policy according to whether it 'complies', 'a conflict may occur' or it is 'not applicable' to the ANDP Sustainability Objectives.
- 4.2. Screening of the ANDP has been carried out and following consultation with SEA bodies this SA has been prepared. With specific regard to the Goat Maltings listed status, responses from Historic England and East Staffordshire Borough Council indicate that a Strategic Environmental Assessment of the plan policies would be necessary. The approach adopted in the preparation of the neighbourhood plan is to carry out a full sustainability appraisal, but because of the listing this aspect of policy will be subject to more detailed assessment, identifying which aspects of retention comply and any that might conflict.

## 5. Conclusions

- 5.1. Overall, the Anglesey neighbourhood plan complies with both East Staffordshire Borough Council's sustainability objectives and the newly created Anglesey sustainability objectives. The neighbourhood plan seeks to support sustainable development and the sustainability objectives.
- 5.2. There is a potential conflict between Anglesey Neighbourhood Development Plan and the Town Centre sustainability objectives. This conflict occurs in ANDP Objective 2 (Services and Facilities) and Policy A3 (Improvements to Shopping Areas). The improvements to Anglesey's services, facilities and shops do not actively promote Burton town centre and instead promotes the parish of Anglesey. However, it can be argued to be only a minor conflict as the shops and services on offer in Burton town centre differ from those needed at a local parish level. Furthermore, this is mitigated by policies within East Staffordshire Borough Council's Local Plan which seek to protect Burton Town Centre and recognise the different roles of towns and local centres.
- 5.3. In most occurrences the vision, objectives or policies do not directly relate to this objective as the objective focuses on the town centre whereas the neighbourhood plan is for the parish of Anglesey only. However, policies A4, A10 and A16 all support the town centre sustainability objective by identifying the need to improve walking and pedestrian links between the parish of Anglesey and Burton upon Trent town centre.
- 5.4. The environmental report has been prepared in accordance with paragraphs (2) and (3) of regulation 12 of the Environmental Assessment of Plans and Programmes Regulations 2004 and that there are no significant environmental impacts from implementing the Neighbourhood Plan.

## **Introduction**

1. Each Neighbourhood Development Plan (NP) must meet the Basic Conditions in accordance with para. 8 of Schedule 4B to the Town and Country Planning Act 1990 Act, which was inserted by the Localism Act 2011. The local planning authority needs to be satisfied that the Basic Conditions are met. Amongst these Basic Conditions are the following:

- a) The NP contributes to sustainable development;
- b) The NP does not breach or is otherwise compatible with EU obligations – this includes the Strategic Environmental Assessment (SEA) Directive of 2001/42/EC; and
- c) The making of the NP is not likely to have a significant effect on a European site (as defined in the Conservation of Habitats and Species Regulations 2010 or a European offshore marine site (as defined in the Offshore Marine Conservation (Natural Habitats &c) regulations 2007 (either alone or in combination with other plans or projects) (inserted by Regulation 32 of The Neighbourhood Planning (General) Regulations 2012).

2. Planning Practice Guidance (PPG) contains specific assistance on sustainability appraisal/SEA requirements for NPs. Whilst a Local Plan-style sustainability appraisal is not required, the PPG advises that, by producing a specific statement of how the Plan contributes to the achievement of sustainable development, the requirement under criterion (a) above would be demonstrated. A sustainability appraisal may be a useful way of producing this statement, the PPG advises. (Ref ID: 11-026-20140306)

3. An NP meets the criteria for an SEA as set out in The Environmental Assessment of Plans and Programmes Regulations 2004 if any of its proposals or policies could have ‘significant environmental effects’. Defining what are ‘significant environmental effects’ is not straightforward, but PPG offers the following examples:

“An SEA may be required, for example, where:

- (a) a NP allocates sites for development;
- (b) the neighbourhood area contains sensitive natural or heritage assets that may be affected by the proposals in the plan; or
- (c) the neighbourhood plan may have significant environmental effects that have not already been considered and dealt with through a sustainability appraisal of the Local Plan.”

(Ref ID: 11-027-20140306)

4. Schedule 1 of the 2004 Regulations sets out criteria for determining the likely significance of effects on the environment. The criteria are:

1. The characteristics of plans and programmes, having regard, in particular, to:

- (a) the degree to which the plan or programme sets a framework for projects and other activities, either with regard to the location, nature, size and operating conditions or by allocating resources,
- (b) the degree to which the plan or programme influences other plans and programmes including those in a hierarchy,
- (c) the relevance of the plan or programme for the integration of environmental considerations in particular with a view to promoting sustainable development,
- (d) environmental problems relevant to the plan or programme,
- (e) the relevance of the plan or programme for the implementation of Community legislation on the environment (e.g. plans and programmes linked to waste-management or water protection).

2. Characteristics of the effects and of the area likely to be affected, having regard, in particular, to

- (a) the probability, duration, frequency and reversibility of the effects,
- (b) the cumulative nature of the effects,
- (c) the transboundary nature of the effects,
- (d) the risks to human health or the environment (e.g. due to accidents),
- (e) the magnitude and spatial extent of the effects (geographical area and size of the population likely to be affected),
- (f) the value and vulnerability of the area likely to be affected due to:
  - (i) special natural characteristics or cultural heritage,
  - (ii) exceeded environmental quality standards or limit values,
  - (iii) intensive land-use, and
- (g) the effects on areas or landscapes which have a recognised national, Community or international protection status.

4. It is the responsibility of the local planning authority to decide whether or not any of the proposals of the NP are significant enough for the Plan to require an SEA. The Parish Council submits their NP (and any subsequent version where there have been significant additions or deletions) to the local authority and the latter produces this screening report, with a statement as to whether or not it considers that an SEA needs to be prepared.

5. The Council will also state whether it considers that there will be a significant effect on a nature conservation site of European significance, as in paragraph 1(c) above, and whether or not a Habitat Regulations Assessment (HRA) will be required.

6. The Council has analysed the NP's policies and proposals against the criteria above, and the results are set out in the chart below.

7. The Government's PPG advises that the local planning authority should consult the statutory consultation bodies. The three statutory consultation bodies whose responsibilities cover the environmental considerations of the Regulations (Environment Agency, Natural England and Historic England) have been consulted. They commented as follows:

**Environment Agency:**

"With regards to Anglesey I note they recognise the impact of flood risk and the assessment that will need to be undertaken to ensure sites that come forward are suitable. Anglesey is entirely in the flood plain, although defended so any proposed sites will need to consider the impact should those defences become breached.

Taking the above into consideration, with regards to the screening opinion for both these Neighbourhood Plans, [Anglesey and Stabenhill] we consider the plans would not have significant environmental effects and, as a result, a SEA of either plan would not be required."

**Natural England:**

"Natural England does not consider the NDP need be accompanied by a HRA as proposals are unlikely to result in significant effects on the [River Mease] SAC.

"We note that whilst the proposed policies of the ANDP are allocating 3 new sites for development , they are unlikely to have significant environmental effects that have not already been considered and dealt with through a sustainability appraisal of the emerging Local Plan which is now at an advanced stage. Neither does the Plan Area contain sensitive natural assets that may be affected by the Plan policies.

"Therefore, it is Natural England's understanding that it is likely this Plan does not require a Strategic Environmental Assessment (SEA)."

**Historic England:**

"On the basis of the information supplied, including that set out in the draft plan, and in the context of the criteria set out in Schedule 1 of the Environmental Assessment Regulations [Annex II of 'SEA' Directive], Historic England is of the view that the preparation of a Strategic Environmental Assessment is likely to be required as land allocations are made and any development proposed could affect heritage assets."

"As regards the HRA Screening Report Historic England does not wish to comment in detail and would defer to Natural England and other statutory consultees, however, we have no adverse comments to make on the report's conclusions."

8. As a result of the above, East Staffordshire Borough Council believes that the above Neighbourhood Plan **would** have significant environmental effects and, as a result, a Strategic Environmental Assessment of the Plan **will** be required.

### **Habitat Regulations Assessment**

9. East Staffordshire Borough Council concludes that a Habitat Regulations Assessment **would not** need to be carried out as it is not considered to be a large enough plan area or involve complex policies which are likely to have a negative impact on habitats. (See Natural England comments above).
