Eligible households will receive an advice visit by an NEA trained¹ Environmental Health Officer to identify suitable energy efficiency measures from the list of those being made available. The national cost of living crisis is well documented, and the Council is committed to providing appropriate support to residents. Households need to meet the following criteria to be eligible for the scheme: Energy Performance Certificate² D or below In receipt of Council Tax Reduction, or have an income below £31K The scheme will target 150 properties; with an average spend of £350 per property and a maximum £500 cap, to provide meaningful assistance to as many households as possible within the funding envelope. The initial focus will be on properties within the Selective Licensing area,³ and those about which complaints have been made,⁴ or which are in the process of applying for / receiving a Disabled
	recommend the scheme and assess what opportunity there is for the household to make savings on their energy bills.
	The available measures are as follows:

	- Draught proofing

	Energy efficiency measures will be selected based on suitability and the spending limit, in consultation with the household. All client households will receive a referral to 'Beat the Cold' and Staffordshire Warmer Homes for insulation measures. ⁶
	Households found to be ineligible have the right of referral to the Manager fi they are dissatisfied, whose decision will be final.
	Three contractor quotes will be requested for the cost of installing the above measures using Quick Call.
	This scheme is part of a package of measures being taken forward under this work stream, so alternatives have not been rejected at this stage.
