<p><b>B1</b> What is the Decision?</p>	<p>To award a capital grant of £12,500 to St Marys Church Stretton following the panel approval of an application to the Council's Ward Enhancement Programme, funded by the UK Shared Prosperity Fund.</p>
<p><b>B2</b> What are the reasons for the Decision?</p> <p><b>B2</b> Alternative options considered and rejected?</p>	<p>The Ward Enhancement Programme (WEP) was approved by Cabinet in September 2023 and created a £1.5m funding programme, financed by the UK Shared Prosperity Fund (UKSPF), through which communities across the Borough could access capital funding to deliver projects in their local areas that improve prosperity, heritage or tourism.</p> <p>The WEP operates on an application basis whereby local community groups and other organisations can apply for capital funding with their application being considered and reviewed by a Member panel comprised of 5 Councillors and chaired by the Cabinet Member for Regeneration and Development.</p> <p>At the panel meeting on 25<sup>th</sup> April 2024, an application was approved for the delivery of a project titled: Re-surfacing of Stretton Church Hall Car Park with improvements to access to site and building, which aims to do the following:</p> <p>The existing car park area surrounding the Hall has developed over 25 years a large number of potholes and has an uneven surface. This presents a trip hazard to pedestrians and some jolting for vehicle drivers including the local mobile library which visits once a week.</p> <p>They wish to contract to resurface the whole car park area and at the same time smooth out two steps to the entrance and fire exit to ease passage of those with mobility issues. As well as improving access they anticipate the project will improve the appearance of the Hall amenity and so enhance the immediate neighbourhood.</p> <p>A grant award of £12,500 was approved for this project, subject to the taking of this Executive Decision by the Cabinet Member.</p>

<b>B3</b> What are the contributions to Corporate Priorities?	The delivery of the Ward Enhancement Programme primarily contributes to the priority of Creating a Prosperous East Staffordshire, Protecting our Heritage, and Standing up for our Communities.

<b>B5</b> What are the financial implications?	<p>The main financial issues arising from this decision are as follows:</p> <p>The funding approved for this project is entirely capital and must be spent by March 2025, in line with the Government's requirements for the UKSPF.</p> <p>The funding is provided through a grant agreement and paid in advance of the project in order to finance its delivery. If the project requires any co-funding, proof of this being secured will be reviewed prior to any funding being released by the Council. The funding is released in instalments agreed with the applicant. Supplier's invoices requested with proof of payment in the form of bank statements. A site inspection is also undertaken.</p> <p>If the project/works aren't undertaken as outlined and agreed in the approved application (or any minor amendments agreed with the local authority beforehand) then there is possibility of a clawback occurring if the grant hasn't been spent in accordance with the application.</p>

Under s1 Localism Act 2011, authorities have a power of competence to do anything which an individual can do, which includes the power to grant funding to organisations.

The Grant Funding will not amount to a state subsidy under the Subsidy Control Act 2023, as the amount to be granted is less than the Minimal Financial Assistance level of £315,000.

The Terms of the funding will be incorporated into a Grant Agreement that sets out the terms for how the funding must be spent, and will contain claw-back provisions

The funding must also be delivered in line with the Government's guidance on UKSPF funding, including requirements on project promotion and marketing.
