B1 What is the Decision?	To adopt the A-Board Code of Practice

B2 What are the reasons for the Decision?

Advertising Boards ('A' Boards) displayed on the public highway can create problems for users of the highway, including those with mobility difficulties, those who are visually impaired, wheelchair and mobility scooter users as well as those with pushchairs and prams. They can also have an adverse effect on the areas streets and shops, appear unsightly and contribute towards a cluttered street scene.

East Staffordshire Borough Council supports local businesses and recognises the benefits that advertisements brings to the business. Therefore we are introducing an 'A' Board Code of Practice to ensure that whilst businesses still benefit from advertising, permitted 'A' Boards are standardised and part of a safer street scene managed through the introduction of a Code of Practice.

Following a discussion with Staffordshire County Council, it was agreed that East Staffordshire Borough Council would seek to introduce a Code of Practice to regulate and standardise the use of 'A' Boards in Burton and Uttoxeter town centres. This is based on Staffordshire County Councils Commercial Obstructions Policy. An assessment was carried out by Enforcement Officers who visited both the town centres of Burton and Uttoxeter. Numerous 'A' Boards were seen to be displayed throughout both towns. We propose that initially the A-Board Code of Practice should be adopted in High Street, Station Street, Union Street and New Street in Burton upon Trent and the Market Place, Queen Street and High Street in Uttoxeter as these were the main areas identified where the largest concentration of A-Boards were displayed. We propose that any one business is permitted to display one A-Board with the exception of where a business has two entrances on two streets given that the A-Board complies with the standards set.

East Staffordshire Borough Council, along with colleagues from Staffordshire County Council will be responsible for investigating complaints in respect of A-Boards.

Businesses would be expected to be compliant with the dimensions, design and construction aspect of the A-Board Code of Practice by 31st January 2023.

A notification and comment period ran from 26th January 2022 to 7th February 2022. Businesses

	in the affected areas, shopping centres and the RNIB were contacted with the proposals.
