B2 What are the reasons for the Decision?	The 2022/23 Corporate Plan identified a target to conduct consultation with residents on proposals to regenerate the Maltings. A key step in this is to commission architects to develop scheme options and sketches to use to inform this consultation.
	The procurement exercise has now concluded and so this decision confirms the allocation of a budget in order to appoint the preferred supplier.
