B1 What is the Decision?	To make Public Space Protection Orders for the control of dogs and the control of alcohol in public places. (The amendments are shown in the attached appendix).
B2 What are the reasons for the Decision?	The Councils current Public Space Protection Orders commenced in October 2019 and are required to be reviewed every 3 years therefore the council commenced a review of the current Orders in January 2022. A comprehensive consultation exercise was undertaken regarding existing public space protection orders. Some additional and extensions for the control of dogs and the consumption of alcohol and other orders were included. Under Section 59 of the Act, the council can make a Public Space Protection Order if it is satisfied on reasonable grounds that two conditions are met.
	The two conditions are as follows:
	 (a) activities carried on in a public place within the authorities area have had a detrimental effect on the quality of life of those in the locality, or (b) it is likely that activities will be carried on in a public place within that area and that they will have such an effect.
	The second condition is that the effect, or likely effect, of the activities:
	 (a) is, or is likely to be, of a persistent or continuing nature, (b) is, or likely to be, such as to make the activities unreasonable, and (c) Justifies the restrictions imposed by the notice.
	The prohibitions and requirements to be imposed by the Public Space Protection Order are reasonable to include in the Order –
	 (a) to prevent the detrimental effect referred to in subsection (2) from continuing, occurring or recurrence, or (b) to reduce that detrimental effect or to reduce the risk of its continuance, occurrence or recurrence.

The power to make Public Space Protection Orders is derived from the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act"). Public Space Protection Orders have effect for a period of three years. There is provision for a Public Space Protection Order to be extended for a further three years, and on more than one occasion.

The Council has satisfied itself that the conditions stipulated at section 59(2) and section 59 (3) of the Act are met and has consulted with the Police, the Police and Crime Commissioner and other bodies. The Council is also satisfied that the prohibitions and requirements imposed by the Public Space Protection Orders reasonable measures to deal with the anti-social behaviour identified.
