To continue the delegation of the operation of Markets within Uttoxeter to Uttoxeter Town Council for a three year period commencing on 28 th November 2018, with an option to continue after this period year on year until terminated by either party. A grant sum of £4,156 will be paid to Uttoxeter Town Council on 9 th December each year of the Term. This figure will be inflated by RPI each following year. This will be based on September RPI (issued October) prior to that year's payment.
B2 What are the reasons for the Decision?	Uttoxeter Town Council have been successfully operating the Uttoxeter Markets for a number of years on behalf of ESBC. All parties are happy to continue with this agreement.
B3 What are the contributions to Corporate Priorities?	This activity falls under the remit of Promoting Local Economic Growth.
