

1. Purpose of the Report

- 1.1 To consider the Statutory Statement of Accounts for 2018/19 following the conclusion of the work undertaken by the Council's external auditors and to recommend their approval.
- 1.2 To recommend the letter of representation on behalf of the authority.

2. **Executive Summary**

2.1 In accordance with the Audit and Accounts regulations the statutory annual accounts for 2018/19 are appended to this report. Members of the committee are asked to scrutinise these accounts and subsequently recommend their approval to the Audit (approval of Statement of Accounts) Committee, immediately following this meeting. The Audit and Accounts Regulations require that the Council formally approve the accounts each year, this function has been delegated to the Audit (approval of Statement of Accounts) Committee.

- 2.2 The accounts have been subject to audit by our external Auditors (Grant Thornton), and a summary of their conclusions are set out within the Audit Findings Report (elsewhere on the Agenda). Subject to the finalisation of their work, the outcome of the audit work has once again been very positive.
- 2.3 Members should also note that, in accordance with the relevant regulations, the accounts have been placed on deposit for public inspection between 3rd June 2019 and 12th July 2019.
- 2.4 The Code of Practice on Local Authority Accounting published by the Chartered Institute of Public Finance and Accountancy (CIPFA) consolidates the legal requirements as to the form of the accounts. Officers, in compiling the accounts, have adopted the code.
- 2.5 In presenting these audited accounts to this Committee (and subject to their approval) the Council has achieved the statutory deadline of 31st July 2019.

3. Background

- 3.1 The Council's Financial Statements are appended to this report. The outcome of the work undertaken by the auditor has once again been very positive and a summary of these findings is set out within the Audit Findings Report (elsewhere on the agenda). The items highlighted by the external auditors by in large relate to the estimated liability associated with the local government pension scheme (administered by Staffordshire County Council) and matters outside of the Council's direct control:
 - The draft accounts did not take into account the full extent of the impact of the Leisure transfer as Staffordshire County Council were unable to provide the actuary with all the necessary data – this was disclosed in the draft accounts alongside a note to indicate that the impact would not be material. This has been amended in the audited accounts with an impact of £0.04m.
 - Within the draft accounts the actuary had estimated the return on assets figure for the final quarter and this has now been amended to take into account the actual return on assets – an amendment of £0.919m. This is due to Quarter 4 performance not been as positive as anticipated due to the economic conditions (including Brexit and the US/China trade dispute) impacting on UK and global equities. We have received information from Staffordshire County Council that indicates positive performance in quarter 1 of 2019/20 of 7% which is mainly due to a rebound in equity markets.
 - Finally, the in line with the guidance issued by the Chartered Institute of Public Finance and Accountancy (CIPFA) the Council disclosed uncertainties associated with the pension liability due to the McCloud/Sargeant court judgement associated with age discrimination. The case related to judges and firefighters, however it is expected to impact on the Local Government Pension Scheme (LGPS). In June 2019 the Government was denied leave to appeal to the Supreme Court. Whilst there are still significant uncertainties as to how this will be addressed in the LGPS, the actuary has recently estimated the impact of this case (£0.3m) alongside the Guaranteed Minimum Pension indexation (£0.3m). It has been agreed with the

external auditors that this is below our materiality level of adjustment and therefore the disclosure within the draft accounts has been extended to provide more detail for the users of the accounts.

- 3.2 In addition to the above, the Council's decision to sell Dove Way on 15th July 2019 represents a "non-adjusting" post balance sheet event. Accordingly this has been disclosed in the revised accounts (note 47).
- 3.3 The accounts have been prepared in accordance with the 'Code of Practice on Local Authority Accounting in the United Kingdom 2018/19' published by the Chartered Institute of Public Finance and Accountancy.
- 3.4 Key elements of the accounts include: -
 - **Statement of Responsibilities** this outlines the responsibilities of the Council and the Head of Service (Section 151 Officer) in preparing the accounts and also of members in approving the accounts.
 - **Statement of Accounting Policies** this details the legislation and the principles on which the Statement of Accounts has been prepared.
 - Comprehensive Income and Expenditure Account this reports the net costs for the year of all the functions for which the Council is responsible. As such, this statement is fundamental to the understanding of the Council's activities and provides details of how costs are financed from both general government grants and income from local taxpayers. However, this statement measures the authority's financial performance in terms of the resources consumed and generated over the period, but the authority is required by law to set its budget and raise council tax on a different accounting basis. As such there are a number of statutory adjustments that are presented in the Movement in Reserves Statement to reflect the movement on the General Fund Balance.
 - **Movement in Reserves Statement** this statement shows the movement in the year on the different reserves held by the authority, analysed into 'usable reserves' (i.e. those that can be applied to fund expenditure or reduce local taxation) and other reserves. It reconciles the position shown within the Comprehensive Income and Expenditure Statement to the "net worth" shown in the Balance Sheet.
 - **Balance Sheet** this explains the Council's financial position at the year-end. It provides details of the balances and reserves at the authority's disposal, its long-term indebtedness, the long term and net current assets employed in operations and summarised information on the fixed assets held.
 - Cash Flow Statement this shows the inflows and outflows of cash arising from transactions with third parties for revenue and capital purposes.
 - **Collection Fund** this reflects the statutory requirement for the authority to maintain a separate account providing details of receipts of Council Tax and Business Rates and the associated payments to precepting authorities and distributed resources under the Business Rates Retention Scheme.

- **Annual Governance Statement -** This outlines the governance framework within which the Council operates, including internal control arrangements. The statement reports on any significant identified weaknesses, the actions undertaken to rectify these, where applicable.
- 3.5 Since 2016/17 the accounting code of practice required a new expenditure and funding analysis to be incorporated into the accounts. The provides a reconciliation of the figures reported to management/Cabinet in compliance with statutory requirements as part of the Outturn and those published to meet accounting standards and shown within the Comprehensive Income and Expenditure Statement. This is set out in note 5 to the accounts.
- 3.6 The draft letter of representation is appended to this report and the committee is asked to recommend approval of it on behalf on the authority. This letter is a formal record of representations made by the Council to our external auditors.

4. <u>Contribution to Corporate Priorities</u>

4.1 The financial statements underpin all corporate priorities by demonstrating a healthy financial position, providing a strong foundation to enable the authority to meet its objectives.

5. Report - Commentary on Statement of Accounts

5.1 Income and Expenditure Account (Page 11)

- 5.1.1 The General Fund under-spend was £0.416m (page 2 of the accounts). Cabinet have approved this sum to be set aside within reserves and allocated as part of the development of the Medium Term Financial Strategy for 2020/21 onwards. As a consequence, the movement on the general fund balance is neutral (as shown in the Movement in Reserves Statement). The General Fund balance therefore remains at £1.3m, which is consistent with the approved medium term financial strategy.
- 5.1.2 The Comprehensive Income and Expenditure Statement reports a deficit on the provision of services for the year of £1.8m. There is also a net amount required to be credited to the General Fund balance for the year shown in the Movement in Reserves Statement of £2.8m. These two items are offset by a net transfer to earmarked reserves of £1m. Movement on reserves during the year are shown at note 9 to the accounts.
- 5.1.3 The comparative figures for 2017/18 have been adjusted to reflect the latest management structure, as reported within the quarter four outturn report to Cabinet, to ensure a like for like comparison.

5.2 Movement in Reserves (Pages 12 & 13)

5.2.1 As set out above, the surplus or deficit shown within the Comprehensive Income and Expenditure Statement is offset by the various reconciling items to ensure that the movement on General Fund reserves reflects statutory requirements.

- 5.2.2 The Statement demonstrates that usable reserves have increased by £1.1m to £15.7m. This largely relates to the increase in earmarked reserves, as indicated earlier. The main increase in earmarked reserves relates to the surplus on the Business Rates Retention Scheme and the Revenue Outturn. The level of reserves are reviewed each year as part of the development of the Medium Term Financial Strategy.
- 5.2.3 In the current climate, in which we have seen unprecedented funding reductions and face significant uncertainty in relation to future funding levels, reserves are seen as an indicator of financial resilience and sustainability.
- 5.2.4 Unusable reserves are largely those that are kept to manage the accounting processes for long term assets and retirement benefits. These have reduced during 2018/19, largely arising from the change in the pension fund liability (as set out in more detail below).

5.3 Balance Sheet (Page 12)

- 5.3.1 Property, Plant and Equipment Primarily the land and buildings owned by the Council. The figure of £33.8m (£36m -2017/18) is derived from a variety of independent valuations intended to reflect the worth of the assets to the Council not necessarily the sum for which they could be sold. The reduction in 2018/19 largely arises from the annual depreciation charges for the use of assets (£1.6m).
- 5.3.2 The Council has short-term investments (excluding deposits held in call accounts) of £15.1m (£17.4m 2017/18). Cash and cash equivalents stood at to £10.6m (£5.6m 2017/18). The increase in this combined figure largely relates the increase in reserves and increased working capital (including section 106 funding received during the year).
- 5.3.3 Long Term Borrowing stands at £10.7m (£10.8m 2017/18), with short term borrowing remaining at £0.6m.
- 5.3.4 Provisions have increased from £2.2m to £3.1m, mainly relating to the NNDR appeals and claims in line with the budget.
- 5.3.5 The Pension Scheme liability increased as at 31st March 2019 from £52m (31st March 2018) to £60m (31st March 2019). The pension fund liability is calculated by a firm of actuaries and is based on a number of assumptions. These assumptions change from one year to the next in relation to the prevailing economic conditions. The liability has also been revised to take into account the Leisure transfer that took place during 2018/19. The pension liability represents the underlying long term commitment that the authority has to pay future retirement benefits. The fund is regularly assessed to determine the level of future contributions necessary to ensure that it is funded in the long term and any increase in these contributions must be met from the Council's budget. The current Medium Term Financial Strategy includes provision for future increases.
- 5.3.6 Capital Grants received in advance represent capital grants whereby the conditions attached to the grant have not yet been fully satisfied. These amounts include section 106 deposits from developers.

5.3.7 Other long Term liabilities relate to the outstanding sums due in relation to finance leases. The authority has acquired a number of vehicles under finance lease arrangements. This liability has reduced during 2018/19 to £0.9m (£1.4m 31st March 2018) due to planned in year repayments in line with the lease agreements. The remaining sum will be written down as repayments are made to the supplier.

5.4 Cash Flow Statement (Page 13)

- 5.4.1 This statement summarises the movements in cash holdings during the year in common with the presentation required for commercial companies, although the statement is of less significance in the Local Authority context. .
- 5.4.2 Whilst the Comprehensive Income and Expenditure Statement is compiled on an accruals basis (i.e. goods and services are accounted for when they are received or provided), the cash flow statement demonstrates the movement in actual cash paid and received during the year.

5.5 Collection Fund Account (Page 81)

- 5.5.1 The Collection Fund shows an <u>in year</u> deficit of £3.2m, this includes a deficit of £1m in relation to Council Tax and a deficit of £2.2m in relation to Business Rates. <u>However</u>, it should be noted that these positions are after making transfers out associated with prior year surpluses (£1.7m in relation to Council Tax and £2.2m in relation to Business Rates).
- 5.5.2 Overall, after taking into account the balance brought forward from 2017/18, the Collection Fund has a surplus of £3.4m, (Surplus £6.6m 2017/18) which will be redistributed to the respective authorities in future years.
- Overall the accounts presented within the Financial Statements show a healthy position. Through the adoption of proper accounting practices, and the ongoing identification of and actions to mitigate against financial risks, this provides a crucial foundation for the Council to be able to achieve its objectives.

6. Financial Considerations

 - 7.3.1 Inadequate or incorrect financial reporting may result in misrepresentation of the Council's financial position.
- 7.4 The risks do not need to be entered in the Risk Register.
