Standing Regulations			
The fees set out in sections 1-6 above apply only to those residing in the Borough of East Staffordshire at the time of death. The normal requirement for residency is that the deceased lived within the Borough for the twelve months prior to death.			
For non-residents the interment fee and, where applicable, the Exclusive Right of Burial fee is trebled. Non-residents are only exempt the trebling of these fees if either of the following criteria apply:			
1) The deceased had previously lived within the Borough within the last 20 years for a period exceeding 5 years			
2) The deceased was a former resident within the Borough within the last 20 years for a period exceeding 5 years but moved outside the Borough to a rest/nursing home.
