Cabinet noted that there were net pressures against the original budget of £2.4m for the full financial year against a net budget of £11.024m and that the vast majority of pressures had arisen due to the Covid-19 Pandemic and related lockdowns. The Government had provided a number of funding packages to Local Authorities to support them with the Covid-19 related financial pressures and once this actual and estimated additional funding of £2.7m was taken into consideration, there was a small net surplus of £0.3m.
