1. Purpose of the Report

1.1 For the Council to note and approve changes to the Council's Constitution.

2. Background

- 2.1 The Council is required to review its constitution regularly.
- 2.2 This report brings forward the latest proposals for changes.

3. <u>Contribution to Corporate Priorities</u>

3.1 This report does not directly contribute to Corporate Priorities but the Council's Constitution is an important document in enabling the Council to implement the Corporate Plan.

4. Proposed Changes to the Constitution

- 4.1 Part 3H (Planning Committee) Amend paragraph 3.10 to read "The Councillor chairing the meeting must ensure that all aspects of the site visit are run in a fair and orderly manner."
- 4.2 Part 5A (Code of Conduct for Councillors) Amend paragraph 3.7 on confidential information to clarify the provisions on permitted disclosure.
- 4.3 5C (Protocol for Councillor/Officer Relations) Amend to include a new paragraph 6.3 reflecting the fact that timescales for responding to requests for information apply equally to Officers and Councillors alike.
- 4.4 5E (Planning Code of Good Practice for Councillors) Amend paragraph 9.1 to read "The Code of Conduct for Councillors and this Code of Good Practice apply to all aspects of the site visit, including the time spent on the Committee coach when travelling to and from application sites.

5. Re-adoption of Constitution

The Council is recommended to re-adopt the whole Constitution on an annual basis. The proposed new Constitution, with the changes outlined above, is available electronically by using the link at the Appendix to this Report.
