1. Purpose of the Report

1.1. The purpose of this report is to present the Council with the findings of a review of the Council's committees.

2. <u>Executive Summary</u>

- 2.1. Having carried out a review of the Council's committee structure, including undertaking benchmarking with other local authorities and consultation with the Council's Members, this report proposes a number of enhancements to the current Committee structure and Committee Membership. In particular it proposes strengthening the Council's overview and scrutiny function by creating a standalone Audit Committee and increasing the number of scrutiny Committees to three, aligned with the Corporate Plan priorities. The report also proposes a reduction in membership of those committees and the Planning and Licensing Committees as a structure of smaller, more focussed committees can facilitate improvement in engagement.
 - 2.2. The specific proposals for consideration arising from the review are that the Planning and Licensing Committees be reduced from 15 to 11 Members; that the Licensing Committee meeting timings be moved to the evenings; that a standalone Audit Committee be created, along with three scrutiny committees aligned to the corporate priorities, each committee with a Membership of 8;

that there be no changes to the Standards Committee, the Complaints Panel, the Appeals Panel or to the Senior Officer Employment Committee, other than to rename the Senior Officer Employment Committee as the Chief Officer Standards Committee; and that an additional meeting of the Council be added to the Council calendar in September from the 2022 municipal year onwards.

- 2.3. It is proposed that the changes above be implemented with effect from the new municipal year i.e. 13th May 2022, and that a further report be brought to the next meeting of Council with the relevant changes to the Constitution, including setting out detailed Terms of Reference for the new Scrutiny Committees and Audit Committee. It is also proposed that new structure be referred to the Council's Independent Remuneration Panel with a request that they review the Council's current Members Allowance Scheme.
- 2.4. It is also proposed that the Council's approach to Committee Training be reviewed during the next municipal year; that reference to remote/hybrid meetings and relevant legislation where applicable be considered as part of the next update to the Constitution; and that the Freedom of the Borough and Alderman procedures be clarified as part of the next update to the Constitution.

3. Background

- 3.1. The Corporate Plan 2021/22 contains a target to complete a review of Council Committee functions (VFM17), to identify any opportunities for improvement across its Committee structure, include considering Committee sizes and functions, the effectiveness of the organisation's scrutiny and overview approach or any further relevant digital opportunities.
- 3.2. On five occasions during the last four Council administrations (2007, 2008, 2009, 2012 and 2017) the Council has reviewed its Overview and scrutiny arrangements.

4. Contribution to Corporate Priorities

4.1. This report contributes directly to the Value for Money Council Corporate Priority through Corporate target VFM17, however all three corporate priorities of the Council are affected by the subject matter of this report.

5. Report

5.1. Current Committee Structure

5.1.1. The Council currently has the following Committees and membership as shown in **Table 1** below:

5.1.2. The functions and procedures of these committees are set out in Part 3 of the Constitution.

5.2. Review Approach

- 5.2.1. A Working Group of Members was established which incorporated the Leader of the Council, Councillor M Metcalfe, Councillor S Sankey and advised by the Head of Service (Sal Khan), the Corporate and Commercial Manager and the Principal Democratic Services Officer. The purpose of this Working Group was to analyse any findings from the research undertaken and to consider possible recommendations to Council.
- 5.2.2. A desktop benchmarking exercise was undertaken, by looking at the committee structures and arrangements of other relevant local authorities including geographical neighbours and the CIPFA nearest neighbours group. The full list is as follows:

- 5.2.3. As part of the review a survey was sent to all Members of the Council. A total of 30 out of 39 Members responded to the survey, this equates to a response rate of 77%. A summary of the responses in relation to each specific committee have been attached as separate Appendices (A-J) and the complete survey result document can be found at Appendix K to this report.

- 5.3.3.6. The benchmarking and survey responses indicate that membership could be reduced.
- 5.3.3.7. The benchmarking indicates that the timing of the Licensing Committee could be amended, and the member survey suggests a slight preference for amending the meeting time.
- 5.3.3.8. It is therefore proposed that the current timing of meetings be amended to the evening, with the membership of the Licensing Committee being reduced to 11 members.


- 5.3.5.1. From the information obtained, only 2 Councils have Scrutiny and Audit functions combined within one committee. The remaining Councils have the audit function separate to scrutiny, with some having a standalone Audit Committee and others having the Audit function combined with one or more other functions (such as Standards). 5 Local Authorities have a standalone Audit Committee.
- 5.3.5.2. In the main, meetings are held in the evening.
- 5.3.5.3. The number on the committee range from 5 to 17 members, with a median of 9 and an average of 9.
- 5.3.5.4. 11 (50%) of the other local authorities have independent members on the Audit Committee. Of these, 5 committees had 1 independent member; 5 committees had 2 independent members; and 1 committee had 3 independent members.
- 5.3.5.5. The Council is above average with a committee size of 16.
- 5.3.5.6. Full survey responses in respect of the Audit Committee are provided at Appendix D of the report.
- 5.3.5.7. A breakdown of the survey responses is shown in Table 11 below:

5.3.5.8. Responses within the survey also indicate most Councillors are supportive and think that the independent Members should continue within its membership as shown in Table 13 below:

5.3.5.9. In its recent publication "Audit Committees and Scrutiny Committees working together (June 2021)" (link Audit committees and scrutiny committees: working together - Centre for Governance and Scrutiny (cfgs.org.uk)) the centre for governance and scrutiny agrees with CIPFA's recommendation that the functions of the Audit and scrutiny committees should not be combined in a single committee,

stating that "blurring the roles of these functions puts a council at significant risk of weak governance".

5.3.5.10. It is therefore proposed that a standalone Audit Committee be created, with a membership of 8 elected Members of the Council and 2 voting Independent Members who shall not be members or officers of the Council. The existing arrangement of having a separate Audit (Statement of Accounts) Committee will be retained, with a Membership of 8 councillors and of 2 Independent Laypersons (nonvoting) who are not Councillors or officers of the Council or of any Parish or Town Council within East Staffordshire. (The Independent Laypersons are not members of the Committee and cannot vote, but shall otherwise be entitled to participate in the work of the Committee, as under S102(3) Local Government Act 1972, a Committee with coopted independent members cannot regulate or control the finance of the local authority, so the Independent Laypersons cannot be members of this Committee).

5.3.6. Scrutiny Committees

5.3.6.1. The number of Scrutiny Committees per local authority range from 1 scrutiny committee to 4 scrutiny committees.



Table 24: Standards Committee Membership





Table 25: Standards Committee Timing





Table 28: Appeals Panel Timings





Table 31: Development Plan Committee Membership

Table 33: Senior Officer Employment Committee Membership





Table 34: Senior Officer Employment Committee Timings

- 5.4.2. There was a clear theme throughout the survey responses that Member engagement could be improved, and having a structure of smaller, more focussed committees can facilitate improvement in engagement.
- 5.4.3. The Council has had experience of taking a similar approach to its committee structure prior to 2017, which had a structure of 4 scrutiny committees and a separate Audit Committee.
- 5.4.4. The results of the benchmarking indicate that meetings take place in both the day and in the evening, and responses from the survey generally indicated that meeting timings should remain the same (except noting the comments regarding the timing of the Licensing Committee as set out in paragraph 5.3.3.7 and 5.3.3.8 where a small majority favoured a move to evening meetings).
- 5.4.5. It is considered that other current arrangements with regards to timing of meetings remained suitable. If all committee meetings were to take place in the evening then this may cause difficulties in attending other commitments (such as Parish Councils; outside organisations; personal appointments) and could potentially reduce the number of Councillors available to serve on these committees, notwithstanding the additional impact on officers providing support to these committees.

5.5. Committee Training

- 5.5.1. There was also a common theme throughout the survey responses that indicates that there could be improvements to level of member training, and that this would facilitate improvements to the effectiveness of committees.
- 5.5.2. It is therefore proposed that the Council's approach to Committee Training be reviewed during the next municipal year. As such, officers would work with the Human Resources Assistant (Organisational Development & Equalities) and relevant colleagues to facilitate improvements to the training programme for Members in relation to committee involvement.

5.6. <u>Hybrid Meetings</u>

- 5.6.1. Following the onset of the Covid-19 pandemic, the Local Authorities and Police and Crime Panels (Coronavirus) (Flexibility of Local Authority Police and Crime Panel Meetings) (England and Wales) Regulations 2020 ("the flexibility Regulations") were enacted and came into force on 4 April 2020, which permitted entirely remote meetings to take place. These regulations expired on 6 May 2021. ADSO (Association of Democratic Services Officers) and LLG (Lawyers in Local Government) jointly institution proceedings in the High Court in April 2021 to seek clarification of the law to enable Councils to continue to meet remotely, unfortunately the application to the High Court was unsuccessful on that basis that primary legislation is required to continue the provision of remote meetings in England.
- 5.6.2. A call for evidence launched by the former Secretary of State was requested from Local Authorities earlier this year and the outcome of that call for evidence has not yet been published. ADSO and LLG continue to lobby government for clarification on remote meetings and in May 2021 ADSO produced a guidance note on remote meetings entitled "What next for Local Authorities" (link).
- 5.6.3. As primary legislation is required to continue the provision of remote meetings in England, it is proposed that that reference to remote/hybrid meetings and relevant legislation where applicable be considered as part of the next update to the Constitution

5.7. Freeman of the Borough Procedures

- 5.7.1. At the Council meeting held on 26th July 2021, the Leader of the Council informed Council that he would consider the procedures for freeman of the Borough as part of this committee review.
- 5.7.2. After considering procedures adopted by other local authorities it is proposed that it would be more appropriate for procedures for nomination of Freeman status to be included as part of the next review of the Council's Constitution. Reviewing the procedures for the appointment of Alderman could be considered at the same time.

- 6.2. The independent remuneration panel through their report will confirm recommendations to Council based upon any revised committee structure.
- 6.3. Proposals to create a separate Audit Committee are consistent with best practice recommended by the Chartered Institute of Public Finance and Accountancy.

8. <u>Legal Considerations</u>

8.1. Any changes to the Council's Constitutional arrangements, including the creation of new committees or changes to the current membership arrangements, require the approval of full Council. Any proposals to alter the membership of committees must be undertaken in accordance with the

provisions of section 15 of the Local Government and Housing Act 1989 which sets out the principles to be followed when determining the allocation of seats to political groups. This provides that the allocation of seats on committees and sub – committees should be in proportion to a political group's representation on the Council and specifically prevents all the seats on a particular body being allocated to the same political group.

- 8.2. Council will be required to approve new Terms of Reference for the proposed new Audit Committee and three new Overview and Scrutiny Committees, which if approved in principle at the December 2021 meeting, will be the subject of a further report to the next meeting of Council in order to allow the new changes to be implemented with effect from the new municipal year.
- 8.3. Changes to the Members Allowance scheme will be required as a result of the proposed changes to the current Committee structure. The Local Authorities (Members Allowances) (England) Regulations 2003 (as amended) provide that before an authority makes or amends its members allowance scheme it must have regard to the recommendations of the Independent Review Panel (IRP).
