#### 1. Purpose of the Report

1.1. To consider the recommendations of the Independent Remuneration Panel contained in the Supplementary report on Members Allowances.

### 2. Background

- 2.1. The Council is required to undertake a review of its Members' Allowances scheme by its Independent Remuneration Panel under the four year rule. The Local Authorities (Members' Allowances) (England) Regulations 2003 (SI 1021) (the '2003 Regulations') require all local authorities to establish and maintain a panel that must be convened to provide advice on Members' allowances before a Council changes or amends its allowances scheme. The proposals contained in this report recommend a change to the current Members Allowances Scheme.
- 2.2. At the meeting of the Council held on 2<sup>nd</sup> December 2018, the Council appointed Dr Declan Hall, Mr Paul Laffey, Mr Simon Chapman and Mr Shaid Hussain to the Panel.
- 2.3. An Independent Remuneration Panel produced its first report on a Review of Members Allowances in November 2002. This was followed by further reviews in respect of Pensions, Travel and Subsistence and Co-optees

Allowances (July 2003) and Pensions and Licensing Panel Members' Allowances (February 2004), a fourth report (May 2007), a fifth report (March 2011) and a supplementary report on a review of Special Responsibility Allowances for the Chairmen of the Audit Committee and of the Relevant and Better Value Services Scrutiny Committee. The sixth report was produced in March 2015 and the seventh report was produced more recently in March 2019.

## 3. Contribution to Corporate Priorities

3.1. The report contributes to all corporate priorities of the Council.

#### 4. Report

- 4.1. The Independent Remuneration Panel was reconvened to carry out a review in July 2019, to consider whether there should be a Special Responsibility Allowance (SRA) for the new posts of two Cabinet Support Members for East Staffordshire Borough Council and if so, the amount of this allowance.
- 4.2. The report of the Independent Remuneration Panel is attached for consideration. The proposals from the Panel are set out on page 4 and it is recommended that these be adopted.
