The Mayor invited Councillor D Florence-Jukes to put forward and propose the motion at item 11 on the agenda for the meeting, which read as follows:

"This Council notes:

Violence against women and girls (VAWG) takes place every day and can have profound long-term effects on survivors and people close to them.

VAWG can take many forms, including, homicide, domestic abuse, sexual violence, child exploitation, sexual harassment, stalking and honour based crimes.

VAWG remains endemic in our society, highlighted most recently by the appalling murders of Sabina Nessa, Zara Aleena, Sarah Everard and sisters, Bibaa Henry and Nicole Smallman. The murders have launched a wave of anger and protests across the country.

According to national crime statistics in the UK, on average, a man kills one woman every three days.

The ONS reported that in 2020, 618,000 women were victims of a sexual assault or an attempted sexual assault by a manA 2021 YouGov national survey on behalf of UN Women UK found that among women aged 18-24, 97 per cent said they had been sexually harassed, while 80 per cent of women of all ages said they had experienced sexual harassment in public places. A recent OFSTED review into sexual harassment in schools has found that sexual harassment, including online sexual abuse, has become 'normalised' for children and young people. The Government's End-to-End Rape Review found that only 1.6 per cent of rape cases brought to the police result in a charge. Two women a week are killed by a current or former partner (this rose to three a week during lockdown), and three women a week take their own lives following domestic abuse. One in five women will be raped in their lifetime. One in three women will experience domestic violence in their lifetime

Most women who survive domestic violence do not receive justice from the criminal justice system

This Council believes:

Male violence against women and girls is part of a broader culture of misogyny in society. Perpetrators of serious violence usually have a history of inflicting abuse and harassment. Crimes against women and girls that are reported are not effectively investigated. More focus should be placed on changing men's behaviour that on women taking action to make themselves safer.

This Council calls on:

The Leader of the Council to write to the Home Secretary and Prime Minister. Calling for an urgent Royal Commission into male violence against women. Calling for public sexual harassment to be made a crime, as was originally indicated in the Home Office Violence against Women and Girls (VAWG) consultation. To take all necessary action to immediately address the backlog in courts and put in place the funding required so in future the criminal justice system deals with cases promptly to ensure victims get justice and move on with their lives and the rehabilitation of criminals begins sooner. Increase investment in victims' services including in particular, refuges, mental health services and legal aid support for all victims of male violence

This Council resolves to:

Commit to joining other Public Sector bodies, including many Local Authorities, by achieving White Ribbon UK Accreditation

Stand in solidarity with protesters who oppose violence against women and girls

Do all we can as a Council and in our communities to champion the rights and entitlements of women and girls and to tackle violence against them".

261/22 NOTICE OF MOTION

The Mayor invited Councillor P Walker to put forward and propose the motion at item 12 on the agenda for the meeting, which read as follows:

"This council believes that;

Every employee, facing the trauma of a terminal illness diagnosis, should be treated with compassion and understanding in order to assist them at such a distressing time. In society we would expect nothing else, and this should be no different in the workplace.

Limited protections do exist for chronic long term degenerative illnesses at work through reasonable adjustments. However, a terminal diagnosis, where life expectancy is not foreseen by a medical professional for longer than 12 months, should be protected to ensure nobody has to undergo the additional stress and worry about their job.

We note that the TUC has launched a campaign calling for additional employment protections for workers with a terminal diagnosis and has launched a voluntary Charter that employers can sign up to. Currently a million workers throughout the UK are covered by that Charter from the private and the public sector.

In light of that this council resolves to;

- Support the TUC's Dying to Work campaign which sets out a Charter outlining the principles in which terminally ill employees should be treated if they wish to continue to work
- 2) Ensure as an employer to be the best for our people and sign up to the Charter making it clear that we will offer support and understanding in such circumstances
- 3) Ensure as an employer that our employees will be given the freedom to make an informed decision for themselves as to the best course of action for them and their families
- 4) Ensure that all financial details, including death in service benefits, are fully explained so that any decision taken is an informed decision.
- 5) Write the principles of the Charter into our procedures and train our staff accordingly

Encourage employers throughout our borough to sign up to the Charter".
