Objection: New application as a licensed premises with extended opening and entertainment -

Skinny Kitten Cafe, Barton Under Needwood

Dear Licensing team,

Under East Staffordshire Borough Council Licensing Act 2003 and the corresponding statement of licensing policy I anticipate that the grant of the above new license (the license) for extended opening, selling of alcohol (both on and off the premises) and entertainment will be profoundly detrimental to the licensing objectives as applied by ESBC to protect Barton under Needwood, it's residents and businesses.

In laying out my objection I make reference to section 3 (Licensing Objectives), Section 12 (Adoption of Special Policies, Cumulative Impact).

Situation.

Skinny Kitten Cafe benefits from a very central location in the conservation area of the village, it is surrounded in very close proximity by residential dwellings ranging from family homes to small retirement style flats and a number of commercial office/studio lets. The site is historic, containing several listed buildings and very tightly space constrained. I believe that the cafe has little or no parking of it's own.

To the South of the cafe is a private courtyard with shared access between a different group of commercial tenants. To the West is a shared parking area at the rear of several other properties. Access to the rear of the cafe is by means of a long and winding gated path running West through this shared parking but only approximately 1m wide, whilst at the front, access is directly on Main Street which runs very closely outside. So close as to require mention that this is one of the main vehicular black spots in the village, particularly when delivery vehicles are serving nearby properties. Main Street is a very busy road at all times of the day with all types of vehicles from cars to heavy agricultural vehicles, buses and HGV's. Children from John Taylor High School make full use of all of the amenities on Main Street throughout the day and after school. This particular space is a natural location for a cafe from 08:00 to 17:00 say, not for an entertainment venue from 08:00 to 00:30 hrs.

The grant of the proposed license will enable this small cafe to grow use as an entertainment venue, selling intoxicating drink and operating during late hours, well past the time most people who are not revelling are in bed trying to sleep. This will be highly detrimental to the council's stated licensing objectives. There is a well understood correlation between the sale of intoxicating liquor, crime and disorder and nuisance.

Public Nuisance and Noise

A main bedroom in our own property, overlooks the outside garden terrace of the cafe only 5 metres away! We are therefore convinced that the grant of the license will increase noise nuisance, coming and going, antisocial behaviour, passive smoke drifting into our bedroom windows, to name but a few nuisance types. The private courtyard and the shared parking area are well know by local residents who object to/or have

to regularly remove people leaving the pubs to urinate there. Another licensed premises will add to the potential for this to happen. Skinny Kitten is very poorly served by sanitation facilities (one small downstairs toilet) making this extreme nuisance act all the more likely during busy times. Noise nuisance emanating from the current pubs is already a problem on Main Street, once again, another licensed premises will make this worse.

Skinny Kitten is situated in a very old building with single glazed windows, poor insulation and no soundproofing. At no time has the building been designed to suit the purpose for which the license has been applied. At busy times windows will be opened to allow ventilation into the building. The garden terrace will be used by smoking patrons. The noise of intoxicated people, music, coming and going, deliveries, bottle clearance will constitute a high level of public nuisance to all who live nearby.

Lighting upgrades at the rear of the property have already taken place without consultation. These lights shine across private spaces and into our bedroom windows thereby constituting light pollution nuisance. I respectfully ask for the council to enforce their removal since the cafe nor the public have any access rights from the shared courtyard they illuminate.

Public Safety

As mentioned above, Skinny kitten has very poor pedestrian access, almost no vehicular access and no disabled access. The pavement outside the front door measures only 88cm from a high step to the main road. The potential for patrons to fall into Main Street on exit with lethal consequences is increased dramatically with sale of alcohol. The front access is also situated directly on the bend in the busy Main Street. Although this bend is not acute, it does impair the vision of drivers sufficiently to compound this threat by reducing reaction times.

Inside the building it is noticeable how many trip hazards exist, uneven flooring, several low level steps, low ceilings and blind corners. These may well be manageable by risk assessment for the current use. However, if that use is changed to include drinking alcohol, higher standing capacity and night time entertainment the risks are significantly increased and pose a threat to safety.

In the event of a fire the only exits are down a tight path at the rear or directly out into the busy main road at the front. More occupants more of the time, intoxicated, equals more risk if a fire occurs. I am confident that the council will nominate a suitably qualified body to assess this risk.

The garden area may be used for smokers, but it is small with an enhanced risk of passive smoking. People smoke more in the evening with the effects of alcohol than during a cafe visit in the day. Smoking detritus discarded to the shared areas and private courtyard is a fire risk.

Prevention of harm to children

Another premises selling alcohol and providing off sales increases the likelihood of vendors supplying under age children who may falsely or in breech of license conditions buy it and consume it nearby. (See nuisance) Dual use as a cafe with patisserie will attract children to the venue as a matter of course.

Music for the purpose of entertainment at Skinny Kitten (as distinct from background music).

We do not know what is contained in the application but wish to draw attention to legislation which specifies that a venue capacity of 200 persons is a requirement before music or dancing is allowed for the purpose of entertainment. Skinny Kitten does not have such a capacity.

Cumulative Impact

This section of Main Street (approximately 300m long from the Red Lion to the Three Horseshoes) is well served by four large public houses and off sales sites, a number of whom enjoy a late license facility but have sufficiently spacious and enhanced sites to be considered fit for purpose. I specifically refer to the Red Lion, The Middle Bell, The Shoulder of Mutton and The Three Horseshoes. Clearly off sales are available at the Co-Op and the Liquor and Allsorts convenience store. There is good provision for entertainment at many of these sites and at the new Marina complex. The licensing objectives will not be supported by the addition of another venue at Skinny Kitten Cafe.

I wish to object to the application by Stephanie Holmshaw to supply alcohol on and off the premises from 09:00hrs to 00:30hrs Monday to Saturday at Skinny Kitten Cafe, 23-25 Main Street, Barton under Needwood, Burton upon Trent, DE13 8AA

I live at Salames Court, Main Street D

Our residential property backs directly onto the rear of Skinny Kitten. Please refer to my plan in Appendix 1 attached We already experience noise from Skinny Kitten customers:

- using the rear customer access to Skinny Kitten which **runs along the boundary wall** less than 2 metres from our kitchen/living are [see picture 1 attached].
- using the Skinny Kitten's outside seating area and smoking area located next to our boundary wall less than 2
 metres from our house [see picture 2 attached]
- Noise from these two areas is amplified as it bounces off brick walls that are in close proximity.

The café currently operates Monday to Saturday 9:00am to 5:00pm


If customers were allowed to consume alcohol on the premises, there would be a significant increase in noise levels causing unacceptable public nuisance. With extended opening hours, this noise could last beyond 00:30hrs as (drunken) customers use the outside seating area and outside smoking area. Customers would also congregate in the Skinny Kitten car park before dispersing down the Main Street. Skinny Kitten is surrounded by residential properties in close proximity.

The front entrance to Skinny Kitten is highly unsuitable for a "drinking establishment". Customers step onto a narrow outside step and then onto a very narrow section of pavement (this is the narrowest section of pavement in Main Street). It is not possible for 2 people to pass by each other at this point on the pavement without one of them stepping onto the road. If a customer's judgement is impaired by alcohol there is a significantly increased risk of personal injury to either passers by or the customer or as they leave via the front entrance.

There are already 4 long established premises serving alcohol within a 250m section of Main Street (Three Horse Shoes, Shoulder of Mutton, Middle Bell and Red Lion), as well as the CO-OP's off sales. I already suffer instances of being woken (any time between 23:00hrs - 02:00hrs) by drunken behaviour. Indeed I have previously witnessed people urinating in skinny kitten car park.

The increase in noise causing public nuisance would have a detrimental impact on our health. NHS guidelines clearly state that "lack of sleep can affect your overall health and make you prone to serious medical conditions, such as obesity, heart disease, high blood pressure and diabetes".
