
The Parish Council have seen the licensing notice for Sloan's Kitchen at Craythorne Farm, Craythorne Road. We wish to formally object to the granting of a license.

The Parish Council objects on the grounds of increased noise to neighbours from both music and traffic, and the unsafe entry and exit to the carpark from Craythorne Road which is actually a narrow lane with little lighting. There is no footpath either side of the road so the safety of pedestrians leaving the site would be of huge concern.

We would also question why a license for the sale of alcohol would be required from 0900, and would be eager to understand the nature and frequency of events.

Re: Application for sale of alcohol and live music events - Sloans Kitchen

We are writing to object to the above application at Barn 1 Craythorne Farm in Stretton. We are a semi retired couple, who have recently purchased our bungalow which is currently being renovated. After a long working life we are looking forward to some peaceful life in my childhood village.

We currently live near a business, which used to be a farm, which now holds many events throughout the year. In the summertime the noise disturbs our peace in the garden with friends, and when our windows are open. In the wintertime the noise and light is most distracting. When the business first started the disturbance wasn't so noticeable but as it has grown from strength to strength so has the noise and other distractions. This is one of the main reasons that we decided to move.

This application is disturbing to us for the reasons below;


- 1. The application for the sale of alcohol from 0900hrs to 2300hrs seven days a week is far too broad to allay the fears of local residents wishing to lead a peaceful life. This is highly likely to lead to disturbance from customers and taxi drivers collecting their passengers late at night (possibly well after midnight) when residents are trying to sleep. Therefore, it could create disorder in a quiet residential road, which is more like a country lane.
- 2. The same applies to the application for live music events, which could be held either outside or inside at any time of the day or night. The noise levels would be unacceptable, particularly if a PA system or amplified music is used. Even if the music is played inside it is highly likely to be a disturbance when windows and doors are left open. With the smoking regulations requiring smokers to depart the premises then it is obvious that the doors will be opened regularly.

- 3. Lighting levels in the winter months could become an issue, not just for the music events but due to customers leaving the premises late at night.
- 4. Residents may also be concerned about strangers accessing their properties whilst in an inebriated state. Whilst it may be a joke to the customers it most certainly would not be to the residents, creating a high possibility of causing friction and public safety.
- 5. The applicants business is at the highest point on Craythorne Road, giving it an elevated position for distribution of sound and light disturbance. Additional traffic will definitely prove an issue as it is a very narrow road, approached from either Stretton or Rolleston villages. Parking and manoeuvering of Hehicles on such a Road is not easy and could encroach on residents' driveways and frontages.

All of the above is of great concern to us and we sincerely trust that commercial gain will not over-rule the residents' need and entitlement to quiet enjoyment of our homes. These are understandable concerns, given our experience of a similar venture. We understand that the applicants business is a new one but find it difficult to understand their reason for the need of a licence for fourteen hours a day, seven days a week. Once a licence has been obtained it leaves it far too open for events to get out of control, which would then lead to much worry and concern for the local residents.

If the applicants could be more open and specific about their plans then maybe some of the residents' concerns could be addressed.

- 1. Noise from Live Music Events on a regular basis will no doubt cause a disturbance to what is essentially a quiet rural area. The venue itself is small so there is concern that these events will undoubtedly spill over to the outside resulting in more noise and disturbance reaching our property (which is only three doors away) thereby preventing us from opening our windows at night. This is not just one night of the week but every night giving us just one night at week from the noise and disturbance this licence will cause.
- 2. The Sale and Consumption of Alcohol will potentially lead to rowdy behaviour from intoxicated customers leaving the premises. This is of great concern to us as most of the residents around the venue are elderly/ retirement age and live here for the peace and quiet this area gives them. Although the application is for opening hours from 9am - 11pm this will no doubt result in noise and disturbance till midnight!!
- 3. Additional increase in traffic to the neighbourhood is of great concern to safety. This lane is already busy due to traffic calming measures in Rolleston forcing traffic through Craythorne Lane. There is limited parking to the venue with the entrance being on the brow of a hill and our concern is customers will park on the road to what is an already narrow lane, getting off our drives at the moment is difficult due to visibility of bends if we get patrons parking on the road side then it will be nigh on impossible to exit our drives safely. There is also the added problem of taxis turning up dropping off and picking customers up sounding their horns late at night to attract the attention of customers and using our driveways to turn around. We already have this problem with taxis doing this however this is not on a regular basis which will be the case if this venue is given the license to go ahead with opening every day Monday-Saturday 9am -11pm.
- 4. We are very concerned to hear about this application for a alcohol and live music events license on a regular basis and wonder why, given the location residents were not informed. If granted this will severely affect our peaceful existence that we currently enjoy. Whilst we have no objection to the venue being used as a cafe, we do object to long opening hrs Monday to Saturday from 9am 11pm and the existence of live music events and selling alcohol in such close proximity to all our properties. We respectfully ask the East Staffs Licensing Committee to consider the disturbance and noise pollution or the residents and the road safety aspect, not just for the residence but for the safety of the many walkers who regularly use this road and reject this application.

I believe that having a licence to play live music events and serving alcohol between the hours of and is totally unacceptable in a rural and residential area at Craythorne farm the sound would travel and cause great disturbance to local residents as It is very close to the local houses and bungalows. It will become known as a local night club attracting youngsters from surrounding villages as well as Stretton.

At the moment it is a nice small coffee shop which is open during the day and attracts dog walkers and people wanting to go for breakfast, morning coffee, lunch or afternoon tea in nice surroundings.

There are no footpaths on Craythorne road and poor lighting in places people walking to the venue would be in great danger of getting hit by a car.

Should at a later date they were to expand through to the next business there would be more traffic and not enough car parking space. Which would leave cars being parked on the road which is very narrow and not well lit in the evenings an accident waiting to happen.

I believe with the sale of alcohol on the premises would cause disturbance from intoxicated customers leaving the premises late at night or even the early hours. One only has to imagine the empty bottles being thrown on the road as they walk home causing a nuisance. Craythorne road is beginning to become a dumping ground for Mac Donald's and other fast food outlets please do not let it get worse.



- 1. This is a quiet, rural neighbourhood. Live music events will undoubtedly cause disturbance.
- 2. This is a quiet, rural neighbourhood. Sale/consumption of alcohol will more than likely cause disturbance and rowdy behaviour.
- 3. Additional traffic to and from the venue will cause disturbance and possible disruption to what is a relatively quiet road. The turning (and it's position on the road) in and out of the venue is not suitable for any additional traffic.
- 4. Our bedroom window opens almost directly onto the courtyard of the venue. Previously (while the venue was used as a cafe) a live music event was held by the previous operator. The noise from the music into our house was unacceptable but we did not complain as this seemed to be a "one-off" event. However, we could not accept that level of disturbance on a regular basis. (See attached photo taken from our bedroom window; shows close proximity of barn.1.)
- 5. The application for opening hours is until 11.00pm. This will undoubtedly result in noise and disturbance from the closing time and up until midnight.
- 6. Noise from the recycling of empty glass bottles (more than likely at the end of the night) will cause additional distrubance.
- 7. Noise from customers arriving and leaving the venue.
- 8. Noise pollution from customers stood outside smoking.
- 9. Pollution from customer's cigarette smoke entering our open windows.

We are very concerned to learn of this application and fear that, if granted, this would severely affect our peaceful existence we currently enjoy. We respectfully implore the East Staffs Licencing Committee to reject this application.
