LICENSING ACT 2003 - PERSONAL LICENCE – DECLARATION OF CONVICTIONS

We refer to the above matter and it has come to light following a recent article in the local newspaper, The Burton Mail on the 17th January 2019 that you have been convicted of an offence of Battery. You have also failed to notify this Authority, East Staffordshire Borough Council, of this as well as a change of address contrary to your Personal Licence conditions.

The Authority has considered this matter in light of you being the holder of a Personal Licence and as such hereby serves you with Notice that the Licensing Authority is considering revoking your Personal Licence under Section 124 of the Licensing Act 2003.

You should note that a Personal Licence may be revoked if the Personal Licence Holder has, at any time before or after the grant of the Licence been:-

(a) convicted of any relevant offence

The Licensing Authority therefore has the power to revoke your Personal Licence under Section 124 of the Licensing Act 2003 as a consequence of the assault conviction. This is because since the grant of your Licence you have been convicted of an offence which is identified as a 'Relevant Offence' under Schedule 4 of the Licensing Act 2003.

As the Authority is considering revoking your Personal Licence, the Authority must give you as the Licence Holder notice of this. This Notice therefore invites you to make representations about the Conviction, any decision of a Court in relation to the Licence, or any decision by an appellate Court if you have appealed the decision. You may also decide to include any other information, for example, about your personal circumstances in the representations made. You have 28 days to make your representations, beginning on the day that this Notice is issued. The Licensing Authority does not need to hold a Hearing to consider the representations. Before deciding what action to take, the Licensing Authority must consider any representations made by you, any decisions made by the Court or appellate Court in respect of your Personal Licence of which the Authority is aware of, and any other information which the Licensing Authority considers relevant.”

Last date for any representations to be made by you will be Monday 18th March 2019.
