#### **Licensing Objective**

#### To prevent crime and disorder

It is a well known fact that the consumption of alcohol is a major contributor to crime and disorder. There are a number of premises already along this street and in the area that sell alcohol throughout the day and night. Two doors down from the proposed shop is an off license, approximately 100 yards north along the street is a Polish off license and within 200 yards there are two public houses and also the Stapenhill Institute/Club. It is not unusual to see drunk people walking up and down the street from morning until night and if you venture into Stapenhill Gardens you will witness drunken behaviour from all ages of people (not just teenagers) who are a nuisance. By providing another off-license you are exacerbating the problem and making Stapenhill a less desirable place for families to visit and live.

Along with the drunken behaviour comes the litter problem. Often we will have to clear empty beer cans and bottles from the bottom of our front garden steps and also if you walk along the street despite litter bins being provided you will see an array of alcohol related litter.

#### **Public Safety**

The proposed off license is located on the side of the street where double yellow lines operate and the bus stop is directly outside the shop. There is already an issue when people park on double yellow lines on that side of the street because there are not any spaces to park on the opposite side of the road as this is mainly used by residents. Parking in general is an issue along this stretch of the street - in fact quite often cars will be parked along the road and right onto the junction of Ferry Street. This is very dangerous as it limits visibility when trying to pull out of the junction from Ferry Street. Going back a number of years, special surfaces were laid on this road in order to improve road safety and visibility for both pedestrians and drivers but this now seems to have been forgotten about. If this new off-license is opened cars could be potentially be coming and going until late at night.

#### To prevent public nuisance

(Please see remarks above in crime and disorder)

We think that opening another off-license that is open until 11pm at night will create further public nuisance. We have lived in our home since 1996 and there has definitely been a decline of behaviour locally. In the evening quite often there is noisy and rowdy behaviour from drunken people and we feel having yet another outlet to sell alcohol will worsen the problem and it will go on longer into the evening.

#### To protect children from harm

Main Street is a residential street where families with children live. We have to deal with noise and people traffic from the various premises that sell alcohol. The paper shop and off license two doors down from the proposed off-license is open from 5 am in the morning until 10pm at night and is family run and they do show regard for local people. This new off-license is proposing to open until 11pm at night - this will create more noise and will attract yet more drunken anti-social behaviour opposite and next to homes where children are sleeping.

We do worry about behaviour along the street and in Stapenhill Gardens where children should be safe to walk and play. Stapenhill Gardens is a pleasure ground for families to visit and relax - we live in Stapenhill and as adults quite often feel uncomfortable having to walk past people who are drinking alcohol. I have in the past needed to contact local police when I have seen threatening behaviour displayed by people drinking alcohol towards a young female.

Stapenhill is a deprived ward in the town and putting yet another premises that sells alcohol on this street does not add anything beneficial for the local community where promoting good health and behaviour to children is important for their future.

To whom it may concern,

I am writing to vehmently oppose the application of yet another off licence at 42 Main Street, Stapenhill, DE15 9AR made by Sukhdeep Singh.

My family and I live directly opposite the proposed off licence. It has up until recently been used as a resale shop that has opened during the daytime. Two doors down from the proposed off license is already a paper shop/mini market/ off licence that is open from approximately 5.00 in the morning until 21.00 at night time. The previous owners of the business opened from approximately opened from 5.00 until 18.00. The proposed off license application is to open from 6.00 until 23.00. Approximately 100 yards north along the street is a Polish mini market selling alcohol and then approximately 200 yards south up the street is a mini market/off license also. Within 200 yards there are two public houses and one club all selling alcohol.

Main Street is a residential area where families live with children and people who have to get up in the morning to go to work. We currently have to deal with the noise and people traffic caused when the pubs close at night time. During the summer months this issue is worse when the noise spills out of the pubs because they have the doors open. There is noise caused by cars that pull up outside the paper shop/mini market from 5 am in the morning. Opening another off licence will just add further noise directly opposite to residential properties.

Stapenhill is a deprived ward in the town and yet another off license is surely not adding anything beneficial for the local community.

There is also an issue with parking. The proposed off license is located on the side of the street where double yellow lines operate and the bus stop is directly outside the shop. There is already an issue when people park on double yellow lines outside the off license two doors down causing traffic chaos and also delivery vans that park outside the Papa Johns Pizza shop that is directly opposite to the Ferry Street/Main Street junction. Visibility from this junction is already dangerous as cars park on double yellow lines on the junction as there are not enough parking spaces for residents and customers at the local shops.

Another issue is the litter that already blights the street from local business.

We have been residents at our property since 1996 and have watched the streets decline. There are business premises down the street that have failed and stand in ruin and the opening of an another business selling alcohol will be another nail in the coffin of what should be a gate way into Stapenhill and Burton upon Trent.







I am writing to object to the planning application for 42 Main Street, Stapenhill DE15 9AR to become an off-licence.

In the immediate local area, there are already two pubs (the New Inn and the Barley Mow) a licensed club (Stapenhill Institute), a licensed newsagent (Wendy's at 38 Main Street) and a general store (the Polish store, which I think has a licence). Slightly further afield (over 200 yards distance) in either direction, there is the Co-op store on Woods Lane, the Spar/Londis store on Rosliston Road, and another licensed general store opposite the end of Saxon Street. Extending the shopping area, the large Tesco store is only a short distance away, across St Peter's Bridge, the Tesco Express store is only about half a mile away on Stanton Road, another off-licence is at the top of Rosliston Road (Bargain Booze?) and there are still several more pubs in Stapenhill plus other small shops which have a licence.

It is difficult to understand why another off-licence is needed in this area of Stapenhill when there are already a large number of premises selling alcohol within a very small radius. In particular, it seems completely unnecessary to open another off-licence only three doors away from Wendy's News which has been successfully running for many years. I'm sure there are plenty of people who enjoy a drink at home, but there are already more than enough outlets to buy alcohol from. I'm also sure that having another off-licence won't be an advantage for the local area or residents.

Another problem caused by a new off-licence would be the noise level. Apparently, the application is seeking for the off-licence to remain open for business till 11pm. There are already some noise issues in the local area caused by late evening customers at the pubs on occasion, and I would not be happy for a new licensed shop to remain open till 11pm.
