Thank you for the noise management plan.

This provides a basic outline of what you will do.

Given the limited number of outdoor events, the 8pm finish times and the fact we don't have complaints from your Premise, I am happy to accept this.

The main point is the noise management plan gets the Premise to consider their impact and noise control. If this Department gets complaints in the future, we can always revisit the noise management plan in more detail. Please also note that if we do get noise complaints this department is obliged to investigate and if necessary, we can take enforcement action under separate legislation and we can also call for a review of the Premise Licence if necessary.

My Licensing Team colleagues have been copied into this email for their information and the requirement for a Noise Management Plan to be in place and adhered to will be a condition of the granting of your Premise Licence.

I need more detail in line with the guidance headings I sent to you previously. A few sentences for each heading will be sufficient.

-It would be a good idea to highlight on the plan, where sound checks will be undertaken from around the boundary. The location of nearest receptors (residential premises) should also be shown on the plan.

-Just explain in a little bit more detail the potential activities that could cause noise impact i.e. types of events you have etc.

-How will you undertake the noise mitigation?

Hello Justin

I work in the Environmental Health Department at the Council and am a consultee for the above application- primarily for noise.

I note that you already have a Premise Licence but this new application include an additional building.

You are proposing live music outdoors in this new application. Would you be able to provide a bit more information on this aspect please? I appreciate that you are proposing outdoor live music only until 21:00 which is good.

There are quite a few residential properties (some new) reasonably close by and I'm just mindful of controlling noise from both indoor and outdoor entertainment.

Within reason, I am not opposed to live outdoor music but I would ask that you draft a Noise Management Plan (NMP) to detail how outdoor live music and any other indoor or outdoor noise associated with the new Premise Licence activities will be controlled. This should include a plan of where proposed outdoor events will take place.

I'm proposing that a NMP be submitted to and agreed by the Council as a Condition of the granting of the Premise Licence- this will need to be agreed by us in place prior to activities taking place under any new Premise Licence. I have attached some guidance to help you draft something. We often ask for a NMP for premises nowadays.

Noise Management plan for Shobnall Sports Ltd, Shobnall Soprts & Social Club

Aim/objective

To minimise excess noise and public nuisance due to proximity of local residents

Define a program to monitor noise

Respond to complaints and unacceptable noise

Noise sensitive receptors

Local housing to be included on map

Types of noise

Outdoor music, indoor music, car park, people arriving and leaving and smoking areas

Noise breakout

Windows, doors carpark and smoking areas

Mitigation

Them

Volume, bass volume, doors, windows and speakers

Mitigation to consider

Control noise levels with external sound checks, prior and during events.

Keep doors and windows closed after 9pm

Speakers facing away from doors

Outside music, recorded and live, possible impacts.

Volume and bass volume

Noise nuisance to local residents

Mitigation to consider

Control noise levels with sound checks prior and during events at regular intervals

No outside music after 8pm

Music to be played on the outdoor stage (refer to map) which is 60 metres away from the nearest property

Limited to approximately 6 times a year and in the summer months only on a Saturday

Speakers to be pointing away from residential properties

Music on the porch will be low level controlled background music played until 8pm once a year for a charity event on a Saturday in the summer

Signs to be put in carpark and smoking area reminding guest to leave the premises quietly

Sound checks

External sound checks to be made prior and during events

In any event bands or dj's refusing to adhere to acceptable sound levels the music shall be terminated

The Designated premises supervisor shall have full control

Communication

Send letters to local residents giving them contact details should problems arise during events

Responding to complaints

The DPS and Directors of Shobnall sports Ltd will be present during events and will respond to complaints immediately.

A log will be kept to record complaints and to register actions taken to resolve complaints

Premise hire terms and conditions

A hirer agreement will be in place to include details of dj,s or bands prior to events.

Exclusion policy

An exclusion policy to be implemented for Hirers, bands and Dj's that do not adhere to the noise management plan

Staff training

All staff to have training for events and will be reminded of their duties prior to any events

Annual review

Noise management plan will be reviewed annually or sooner if there are excessive complaints
