

Hi Nicky,

I have attached my duty calculations for the goods and quantity seized. Shisha does contain Tobacco.

Herbal Molasses is another smoking product which does not contain Tobacco but it still attracts the duty as a "other Herbal Product". Since the 1st of January 2014 other Herbal smoking products attracts duty as if they contain Tobacco. As such they do attract duty. If you need more information on this read Public Notice 476 which contains a wealth on Tobacco/Molasses related information.

The goods were seized from The Locomotive Bar, 28 Station Street, Burton on Trent, DE14 1AU. The barman was a at the time of the seizure.


The appeal was an internal review against the seizure of the goods, the review concluded Pam Kaur had provided no proof the duty had been paid, and as such upheld the decision to seize the goods.

The second review was in relation to the decision not to restore the goods, (sometimes we can do this for a fee) again the decision was upheld.

I am an officer of HM Revenue & Customs based at Nottingham.

On 07/11/2019, I was on duty in the Burton on Trent area. At 13:38 hours I entered The Locomotive Bar, 28 Station Street, Burton on Trent, DE14 1AU with officers in accordance with the Customs and Excise Management Act (CEMA) 1979 section 112 and to conduct a search of the premises for Non UK duty paid goods.

I identified myself to

the barman who appeared to be the

responsible person for the premises.

locate two clear boxes of Herbal Molasses and Shisha on top of the freezer in I saw officer the basement. A further quantity was located in the bar in the beer garden to the rear.

PAM KAUR the bar manager phoned, I asked her for invoices for the Shisha and Herbal Molasses, and she confirmed she sold the goods in her bar. PAM KAUR stated the SOEX is purchased from somewhere in Leicester, no further details were provided on the day, and then stated the Shisha



came from Dubai in the post and didn't have any paperwork to show the goods had been duty paid.

PAM KAUR stated she was unaware she was required to pay the duty when importing dutiable goods.

A total of 10.35KG of Shisha, and 4.25KG of Herbal Molasses was seized under CEMA 1979 section 139 as no evidence of duty paid status was provided.

I issued Public Notice 1 (Detailing UK Customs information), 12A (What you can do if things are seized), a Warning of Liability to Prosecution letter, and a seizure information notice was left at the Locomotive bar.

PAM KAUR posted invoices for the goods to me, however these did not prove the goods had been duty paid.



4.25Kg Herbal Molasses @ £4.51 per 30g = £638.52

Total duty = £2193.50

Pam Kaur appealed against the decision to seize the goods, on the 10^{th} of July 2020 at Birmingham Magistrates court the decision was upheld, and the claimant was ordered to pay costs of £400.00 to HMRC.
