APPLICATION TO VARY A PREMISES LICENCE TO SPECIFY AN INDIVIDUAL AS DESIGNATED PREMISES SUPERVISOR

On Tuesday 4th January 2022, the Licensing Authority received a request from Staffordshire Police that the Application Vary a Premises Licence to specify an individual as Designated Premises Supervisor under the Licensing Act 2003 in respect of Locomotive Sports Bar be held in private. That request is based on the sensitive information contained within the evidence.

The Licensing Authority, acting by the Chairman of Licensing Committee, has determined Staffordshire Police's request and has decided that the Public should be excluded from the whole of the Hearing of this application. The Licensing Authority concluded that in this instance the Public interest in excluding the Public outweighs the Public interest in holding the Hearing in Public.
