PLEASE NOTE THE 4 TARIFFS ARE AS FOLLOWS:

**Tariff 1:** For journeys carried out during the daytime with less than 4 passengers the meter should start at £2.00

**Tariff 3:** For journeys carried out after midnight with less than 4 passengers the meter should start at £4.00

**Tariff 4:** For journeys carried out after midnight with more than 4 passengers the meter should start at £6.00

Further to our telephone conversation, under the current climate of fuel and energy increase, we the trade propose these changes. These changes have been deemed necessary due to the following reasons:

- Fuel has increasing 100%
- Adblue which is used for the emission of Euro six engines has increased by 90%
- Engine oil has increased by 60%
- Car parts prices have increased by an additional 30%.
- Budget tyres have increased by 100%
- Branded tyres have increased by over 30%

East Staffordshire Borough Council has enforced us to change our current vehicles to Euro six engines by the end of September 2022, adding a great burden onto the trade. Therefore, we would like these changes to be implemented under the urgent notice of motion, section 14.
