156/16 APPLICATIONS FOR PLANNING PERMISSION

1. P/2016/01254 – Erection of a detached dwelling (amended plans received) - land adjacent to 10 Tower Road, Burton upon Trent, Staffordshire DE15 0NL (Ward: Winshill)

PERMIT subject to the following conditions:

- 1. Standard time limit for the commencement of the development.
- 2. Compliance with the approved plans (subject to other conditions).
- Notwithstanding the stated details, approval of all external materials (including colours) and compliance with such, including the garage doors, the front wall and railings and the framework for the open porches and compliance with the approved details.
- 4. Submission and approval of a surface water and foul water drainage scheme and implementation of such (with SUDS being required where ground conditions allow).
- 5. Submission of full landscaping and boundary treatment including details of tree protection measures for retained trees, the planting of native trees and the provision of boundary treatment along that part of the boundary.
- 6. Implementation of the approved landscaping scheme.
- 7. Submission and approval of a scheme regarding sustainable construction and energy efficiency and compliance with such.
- 8. Completion and retention of the approved boundary treatment scheme.
- Completion of the access, parking and turning areas in a bound and porous material/s (with exact material/s to be first approved by the Local Planning Authority) and such remaining available for their dedicated purposes for the life of the development.
- 10. All roof lights to fit flush with the roof slope in which they are set and have black frames.
- 11. All windows and external doors to be set back from outer face of wall by 50mm.
- 12. Removal of permitted development rights for future extensions, outbuildings, external alterations including any new windows and roof lights, boundary treatment for amenity and visual reasons.
- 13. No development shall take place until details of eaves and verges have been submitted and approved in writing.
