The political groups had confirmed their nominations to the Committees and Panels, which were set out in Appendix 1 to the submitted report and duly noted by Council.

Council noted it was proposed that Councillor D F Fletcher replace Councillor M T Fitzpatrick on the Standards Committee.

At this juncture Councillor H Hall read the following statement:

"At the Full Council meeting on 3rd December 2018, Cllr Florence-Jukes stated that I had not been consulted on the changes to committees described in the Deputy Monitoring Officer's Report to Council. In point of fact though I had been emailed by the Deputy Monitoring Officer on 28th August, together with Cllr Grosvenor and Cllr Fitzpatrick, when Mr Ebberley told us that there was a new vacancy on the Scrutiny (Strengthening Communities and Economic Growth) Committee, to be filled by the Labour Group; and that there were two outstanding Conservative Group vacancies on Planning Committee. None of the vacancies concerned my Group. I did not respond to Mr Ebberley's email and by the time I received the agenda for the 3rd December Council meeting I had forgotten that I had received the email in the first place. I checked through my emails prior to the meeting but I did not check back far enough. I accept that my memory lapse resulted in me giving misleading and inaccurate information to Cllr Florence-Jukes, which she then relayed to the meeting without any correction by me (for the reasons I have already explained). I apologise for this error on my part.

I also accept that professional courtesy and the Protocol for Councillor and Officer Relations dictate that I should have contacted the Deputy Monitoring Officer in advance of the meeting to raise my queries over his Report, instead of allowing my Group member to ambush him during the debate on this agenda item. I would now like to apologise to Mr Ebberley for this discourtesy and I accept that he did contact me about this matter a little over 3 months in advance of the meeting.

Finally, I apologise that this meeting has had to be convened, causing inconvenience to my fellow members and to officers and resulting in additional cost to Council Taxpayers."

Resolved:

273/18 UPDATE FROM THE CHAIRMAN OF THE STANDARDS COMMITTEE

Councillor M J Bowering, Chairman of the Standards Committee read the following statement:

"At a meeting of the Council's Standards Committee yesterday evening, Cllr George Allen and Cllr Sue McGarry were both found to have brought East Staffordshire Borough Council into disrepute by breaching the Code of Conduct for Councillors and the Planning Code for Councillors.

The Committee was called for the purpose of hearing six complaints against Cllr Allen and three complaints against Cllr McGarry. One of the complaints against Cllr Allen concerned his behaviour in relation to a planning application for a residential development at land off Westlands Road, Uttoxeter and in that case the Committee found that Cllr Allen had breached the relevant Codes by failing to declare an interest in a property close to the development site and that he had breached the general obligation of Openness by failing to act and take a decision in an open and transparent manner.

All of the remaining complaints, against both Cllr Allen and Cllr McGarry, concerned a planning application for a residential development at Hazelwalls Farm, Uttoxeter. It was alleged that both Councillors had failed to disclose that:

- they were part of an organised pressure group protesting and campaigning against the proposed development;
- that they had attended private meetings of that group unbeknown to officials, been involved in the production of campaign leaflets and had engaged in lobbying as part of the campaign group rather than simply representing residents.

In all those cases the Committee found that both Councillors had breached the relevant Codes as a result of their involvement with the campaign group and they had failed to uphold the general obligations of Openness, Selflessness and Objectivity.

The Committee imposed the following sanctions:

- 1. That its findings be published on the Council website and in the form of a press release;
- 2. That its findings be reported to Council at this meeting on 21st December;
- 3. That the Monitoring Officer arrange training for the two Councillors on the Code of Conduct for Councillors and the Planning Code for Councillors. Such training to be undertaken by 31 January 2019;
- 4. That neither Councillor should be allowed to sit on Planning Committee until the training referred to at 3 above has been completed."

NOTED.
