Statement from Councillor Chris Smith, the Mayor of East Staffordshire

"I am very proud to have served the Council as Mayor for the last 10 months, I have carried out the role with dignity and honour and have tried to carry this forward without using politics. On this occasion I allegedly liked a repost of what I believe was satire about the Mayor of London Sadiq Khan. My personal feelings regarding the way the Mayor of London conducts his affairs are my own and do not reflect the office of Mayor of East Staffordshire or the Borough Council but I do not think Mr Khan is doing a good job as London's Executive Mayor. That is a comment on his political approach to the role and although Mayors have to be apolitical on this occasion my judgement slipped. Other Mayors have themselves found issues in retaining political impartiality and I now fully appreciate that difficulty. I am sorry if I have offended any one by liking this particular post. There must be thousands of satirical posts out there that could offend many people and I want to distance myself from this, and to this end I have removed myself from any form of social media whilst I am Mayor."
