1. <u>P/2018/00343 – Erection of a detached dwelling, construction of vehicular access and installation of septic tank – Field north of Sallyfields Lane, Stanton, Staffordshire (Ward: Stanton)</u>

Members voted to overturn the officer's recommendation to refuse on the following grounds:

1. Members considered that the development is distant and remote from other dwelling.

- 2. Members considered the definition of isolation was apart from the main population.
- 3. The development matches the criteria of isolation as Members considered how far other properties were apart from the development.
- 4. The development site is on the edge of the village.
- 5. The development is set back from other properties.
- 6. In the absence of a clear definition of isolation Members considered the site in question to comply with their interpretation.

- 15. Landscaping implementation.
- 16.1 x Swift brick to be provided.
- 17. Limit the dwelling to a single dwelling only with the annexe to be used as ancillary accommodation only.
- 18. No lighting shall be installed other than that approved.
- 19. Permitted Development Rights removal.
- 20. Area to the frontage to remain free of domestic paraphernalia.
