## 208/22 ANNOUNCEMENTS

The Acting Leader of the Council, Councillor G Allen provided an update to Council on the ongoing work which had begun to support those affected by the situation in the Ukraine. He advised that there had been changes to the Council's website, providing relevant information, advice and assistance to those trying to leave Ukraine. Further to the motion agreed at the previous meeting held on 28<sup>th</sup> February 2022, he indicated that he had been in contact with both Kate Griffiths MP and Michael Fabricant MP and a response had been received from Kate Griffiths MP. #### 209/22 URGENT BUSINESS

"UK national Olena Price who is the Ukrainian fiancé of Marchington resident Neil Hastilow is currently stranded overseas after flying to Poland to try and get her family back to the UK after they had escaped from Kyiv. They were refused entry at the airport in Poland after having visa issues. In addition we now see that ESBC has released a statement saying that we are ready to help people displaced by the war.

Council will recall that item 188/22 on the council agenda for February 28th was an urgent motion raised by me calling on our MPs Kate Griffiths and Michael Fabricant to provide assistance to help get family, partners and friends out of the country. Has the council contacted our MPs to advise them of this motion and what was the response?".

#### 212/22 NOTICE OF MOTION

The Mayor invited Councillor D Florence-Jukes to put forward and propose the motion at item 8 on the agenda for the meeting, which read as follows:

"This Council expresses its shock and sadness to learn of the tragic death from suicide of Mrs Angela Winter. The Council offers its sincere condolences to the late Mrs Winter's family and friends. A recent coroner's inquest found that in June 2021, Mrs Winter and her husband, Michael Winter, were homeless and sleeping rough on the Washlands close to the town centre of Burton for over three weeks after losing their home and jobs during the pandemic. It concluded that Mrs Winter became so distraught about her predicament that she stormed off from Mr Winter. Five days later Mr Winter discovered his wife's dead body in a wooded area close to a children's play area on the Washlands. He stayed with his wife's body for a further three days before alerting Police. The coroner recorded a verdict of suicide from prescribed medication. The incident has attracted widespread local and national media coverage, prompting questions as to how this tragedy could have happened. Staffordshire Live reported that the couple 'fell through the cracks.'

This Council calls for an urgent inquiry to establish what contact and in what capacity, the YMCA Rough Sleepers Outreach Team, the Housing Options Team,

and the Open Spaces Team had with Mr and Mrs Winter during June of 2021 and report findings back to Full Council."

In accordance with Rule 16.31 Councillor D Florence-Jukes proposed an alteration of the motion to read as follows:

"That in response to the tragic circumstances surrounding the death by suicide of Mrs Angela Winter in June of 2021, this Council calls for an urgent scrutiny review by the Community, Regeneration, Environment and Health and Well Being Committee to establish if the current policies and practices involved in delivering a service to rough sleepers are the best they can be, and based on the Committee's findings, make any necessary recommendations to the Executive or ways to improve the service."

The altered motion was seconded.

The Mayor invited Council to debate the altered motion under Rule 16 (Rules of debate).

# 213/22 BURTON UPON TRENT TOWNS FUND PROGRAMME

The report of the Chief Executive on the evaluation of the projects within the Towns Fund Programme was considered. The following appendices had been circulated with the report:

"12.1 That having reviewed the programme and considered the business case assessment as listed in Sections 5.7 and 5.8 of this report, as well as the observations of the Scrutiny Committee held on 9<sup>th</sup> February 2022, Council approves the business cases for Project D, Project G, Project H and Project J and officers submit the necessary Summary Documents to the Department for Levelling Up, Housing and Communities as detailed in the Heads of Terms (as required).

12.2 That the Medium Term Financial Strategy 2022/23 – 2024/25 is updated as detailed in Section 6 of the report, to include:

- The increase to the Capital Programme as identified at Paragraph 6.1.1 to be funded from Towns Fund Grants and S106 monies.
- The increase in the Revenue Budget to incorporate the new Chief Officer – Head of Regeneration and Towns Fund as identified in Paragraph 6.1.4
- To reallocate the use of one-off resources to support the Towns Fund with the suggested delegation as identified at Paragraph 6.1.4
- 12.3 That Council agrees to the principle of the final decision to purchase the Molson Coors High Street Campus property being delegated to the Leader of the Council and Deputy Leader for Finance, in consultation with the Leader of the Opposition, Leader of the Independent Alliance Group and the Chief Executive.
- 12.4 That the Council begins a review of sustainable options for the Market Hall, to include a cross-party working group, with a view to future investment from the Council, subject to viability."

## EAST STAFFORDSHIRE BOROUGH COUNCIL Council Meeting 21<sup>st</sup> March 2022

<u>Question received from Councillor D Florence-Jukes and response from</u> the Deputy Leader (Environment and Housing) Councillor R A Faulkner.

20/22 In November 2020, it was announced that ESBC was to receive an additional £241,251 for local schemes that provide secure 'move on' style accommodation for people at risk of sleeping on the streets. Wil the Deputy Leader provide a breakdown of how this additional funding has been allocated and provide an overview of the outcomes of the expenditure?

The £241,251 was secured by the Council in a joint bid with Trent and Dove to the <u>Next Steps Accommodation Programme</u> (NSAP) Capital Fund [EDR No. 234/20]. The funding comprises both capital and revenue for support until 31 Mar 24. The capital component is £180k for 6 properties (the remainder being revenue) and has been secured under the 'purchase and repair' model, with properties purchased from the open market on long lease to be made available for 30 years for those rough sleeping or at risk of rough sleeping and homelessness. Rent are then set at affordable rent levels, with tenancies for a maximum of two years as residents secure the skills they need to move into general needs housing.

The project funded by NSAP is known as 'Stage 2 Accommodation' for individuals who have made progress in shared supported accommodation ('Stage 1') but are not yet ready for independent living. All properties in the project are self-contained with their own front door to support independent living, and therefore give the residents a sense of progress whilst retaining the support they need to fully integrate into the community. There are a number of skills which can be an obstacle to moving into independent living, and are best worked in a self-contained environment such as: developing the skills to budget and pay utilities / rent, developing hobbies and interests, accessing training, education and/or employment.

To date 5 purchases have completed and 4 properties are occupied by the target cohort, all 4 residents are doing well though none have moved on yet having occupied the accommodation for approx. 9 months in most cases. The 5th property remains void pending repair and allocation, the 6<sup>th</sup> property to be purchased under NSAP has been delayed by lease terms which prevent sublet amongst other issues. Following the addition of funding from the <u>Rough Sleeper Accommodation Programme</u> (RSAP) [EDR No. 287/21] on the same terms as the NSAP funding, there will be 7 additional 'Stage 2' properties bringing the total of 13 properties and 1.3 FTE support staff. So far, there have been 2 properties purchased with RSAP funding both of which are now being repaired. Question received from Councillor R G W Grosvenor and response from the Deputy Leader (Finance) Councillor S Sankey.
