1. **This is a formal notice** which is issued by the Council, because it appears to it that there has been a breach of planning control, within paragraph (a) of section 171A(1) of the above Act, at the land described below. It considers that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Annex at the end of this notice contains important additional information.

#### 2. The land to which this notice relates

The land known as **land at South East Side of the A38**, **Wychnor**, **Staffordshire**, **DE13 8BZ** Staffordshire shown edged in red on the attached plan ("the Land").

# 3. The matters which appear to constitute the breach of planning control

Change of use of the Land from mixed use for the repair, stripping and dismantling of vehicles, storage of waste oil, batteries and other vehicle parts and for the renovation, sale and distribution of vehicle parts; and repair and sale of helicopter components to use in connection with the heliport, helicopter hire and training without planning permission.

# 4. Reasons for issuing this notice

The Council considers it expedient to issue this notice for the following reasons:

- (1) It appears to the Council that the above breach of planning control has occurred within the last ten years.
- (2) It is contrary to the Staffordshire Structure Plan Saved Policy T19
- (3) Highway safety implications
- (4) The Council does not consider that planning permission should be given, because planning conditions could not overcome these objections.

# 5. What you are required to do

- (1) Stop using any part of the Land for and in connection with the heliport, helicopter hire or training.
- (2) Remove the building from the Land
- (3) Remove the Antenna/Aerial from the Land
- (4) Remove all the decking from the Land
- (5) Remove all the hard standing from the Land
- (6) Dispose of all resultant materials from items 2 to 5 inclusive to an authorised waste disposal site.

# 6. Time for compliance

30 days beginning with the day on which this notice takes effect.

#### 7. When this notice takes effect

This notice takes effect on Monday 6 February 2012 unless an appeal is made against it beforehand.

#### YOUR RIGHT OF APPEAL

#### WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this enforcement notice, it will take effect on the date specified in paragraph 7 of this notice and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period(s) specified in paragraph 6 of this notice. Failure to comply with an enforcement notice which has taken effect can result in prosecution and/or remedial action by the Council.
