The Council considers that you should be required to comply with the condition specified in this notice. The Annex at the end of this notice contains important additional information.

2. The land to which this notice relates

The land known as Staffordshire Helicopters and Hi Range Limited, Lichfield Road, Wychnor, Staffordshire DE13 8BZ, shown edged in red on the attached plan known as "the Land".

3. The relevant planning permission

The relevant planning permission to which this Notice relates is the permission granted by the Council on 23rd May 2012 for the retention of a building and continued use as a heliport, including helicopter hire and training under Planning Permission Number P/2012/00261/JPM.

4. The breach of condition

The following condition has not been complied with:

(7) Helicopters operating from the site in connection with the use hereby permitted shall be restricted to R22 and R44 models only unless otherwise first agreed in writing with the Local Planning Authority.

in that an Enstrom 280FX helicopter, registration number G-WPIE, is being used and stored on the land known as Staffordshire Helicopters which is a not a model permitted in accordance to Condition 7.

5. What you are required to do

As the person responsible for the breach of condition 7 specified in paragraph 4 of this Notice, you are required to comply with the stated condition by taking the following steps:

(1) Cease the operation of the Enstrom 280FX helicopter registration G-WPIE.
